## **INTRODUCTION**

1. There is a horrible crime unfolding in Joe Bloom's residence. Joe dials 911. The cops do not come or if they come, they aid and abet the criminals. Victims of unfathomable crime in family court initiated by, triggered by lawyers like Tracy Julian, file complaints such as this one, and the attorney general and judiciary, dismiss all such cases, and fight hard to enable such crime and retaliate against the victims. I have seen this since year 2011.

2. The main goal of filing this complaint is to require the State government to (a) follow the law; (b) protect human rights; (c) protect children's rights; (d) be honest and humane; (e) be ethical, moral, just and fair.

3. If someone asks me to explain in one sentence the purpose of filing this complaint, I would say - we human beings do not come into this world to inflict such

palpable levels of cruelty, evil, injustice on innocent helpless children and parents. No human being should look the other way when anyone is cruel, evil and unjust to any child or any adult. A civilization is on the path to self-destruct if we turn a blind eye to evil and injustice.

4. A human being inflicting immeasurable, palpable levels of pain, cruelty, irreparable harm on innocent, helpless children - <u>this is the worst of mankind</u>. Why will any human being look the other way?

5. In a civilized society, no child, no adult should be a victim of cruelty, evil, injustice.

6. This is eternal, timeless truth ringing through the ages - anyone turning a blind eye to evil and injustice is making the world unsafe for "all of us."

7. I am following the law, I am fighting for human rights, I am fighting for children's rights, and, I am ethical, moral, just and fair. If the State commits to the same, <u>then we are on the same team</u> and there is no need for me or anyone to file such a complaint.

8. With deep disappointment I am filing this complaint.

9. The logical and legally correct step for a victim of any crime, when all doors in the State Courts have been shut - is to knock the doors of the federal courts, and if the federal courts also help cover up crime and corruption, evil and injustice, then God also will not be able to bless America.

10. Through this case, this court has yet another incredible opportunity to protect and serve - (a) to protect at least 50 children being kidnapped every day in family courts all over America. (b) to prevent the enslavement of at least 50 parents every day in family courts all over America.

# PARTIES, PEOPLE REFERENCED IN THIS COMPLAINT

11. Myself - Plaintiff Surender Malhan: Born and raised in India. My father was a Naval Officer. I grew up on various Naval Bases. At 17, I joined the National Defence Academy - top military academy in India. I served in the Corps of Signals for 11 years and left as a Captain in February 1993 due to medical reasons.

12. During my military career, I did (a) a second degree in Electronics Engineering from the Military College of Telecommunication Engineering; (b) and a Masters in Computer Science from the Indian Institute of Technology - top university in India.

13. Far more significant than my formal education, is my self-education, -

beginning when I was in 3rd grade, I have studied several books on a wide range of important subjects - science, psychology, leadership, management, biographies, selfdevelopment, etc.

14. Along side my military career, I devoted all my leisure time to studying and guiding the mental, moral, psychological and intellectual development of children and adults. Based on this work, in July 2022 I <u>published a book - Wisdom of the Ages</u>.

15. In March 1995 I came to the US on H1B work visa. In May 1996 alongside working full time at Chase Manhattan Bank, I started SpaceAge - a software services firm.

16. Past 27 years, rather since my teenage years, I have been working 70+ hours every week.

17. Since I was 17 years old, my goal in life has been consistent - to contribute, to help make our world a little better place. I sum this up in these words in my book and in my work:

"As we are born on this planet we inherit a lot. What we inherit is the result of the sweat and toil of those who lived in the past and those alive. Having inherited so much, our duty is: (a) To preserve it. (b) To add to it in whatever little way we can. And (c) To pass it on to the coming generations."

 In 2003 Viktoriya Myronova and her daughter Alina Myronova were living in Kharkiv, Ukraine. Viktoriya then was 40 years old, and Alina was 19 still in college.
 Viktoriya was divorced in year 2000 and had a boyfriend Borris Sichev.

19. In 2003, Viktoriya and Alina, made the plan, how they can use me to come to America and get their green cards. As part of the plan Alina pretended to be my girlfriend, fiancee, wife.

20. After arrival in US, they saw an incredible opportunity to steal money and unjustly enrich themselves while they waited for their green cards.

21. From the time we met in Ukraine in May 2003 to the filing of divorce on
February 24, 2011, if we follow the money, we can see "one hundred percent" - like any fraudster, they tried to grab as much money as they could, while they waited for their green card. They knew they had the perfect allibi "the marriage certificate".
22. Viktoriya is one year younger to me and Alina is 22 years and 9 months younger to me - (23 years - round figure.)

23. In March 2004 Mother and daughter fraudsters (Viktoriya-Alina) came from Ukraine with mere 2 suit cases. I sponsored and paid for their visa and I paid their travel expenses. Alina and I were legally married in March 2008. Alina lived with me for 6 years and 7 months. I gave them employment in my business for 6 years. I paid them salaries 4 times over (unjust enrichment). On Feb 24, 2011, after getting her green card, Alina filed for divorce.

As of Feb 2011, there were 7 units in joint name – myself and Alina, of which one is my residence (2L) – pre-marital asset where I have lived since May 1996.
As of Feb 24, 2011, Viktoriya had amassed over \$700,000 in cash and assets (from me) and Alina had over \$29,000 in her bank account. Over \$300,000 was stolen from marital assets. Over \$100,000 was stolen from my business SpaceAge. As of Feb 2011, Viktoriya had 4 units in her name. Two were my office units which I bought back from her – post marital. After filing of divorce in 2011, from selling the two office units 1M and 1N back to me, -- Viktoriya (using my money) made over

\$250,000 in profit in less than 2 years.

26. This we all know. In all crimes the most clear and convincing proof of crime is, "follow the money".

27. Since the time I met Alina and Viktoriya met me in 2003 in Ukraine and continuing after they arrived in the US and till the filling of divorce, - consistently their goal was typical of any fraudsters - to grab and walk away with as much money as they can. They had the perfect alibi "marriage certificate". They had the perfect safe haven - the Family Courts. Rather everyone exploited Alina - they had their knee on her neck, so as to extract out all our combined assets and earnings for the longest duration.

28. In their very first two years in the US (2004-2006), together they had stolen and unjustly enriched themselves with well over \$100,000 from me and from my business.

29. In 2004, Alina had a bachelor's degree in languages. I encouraged her to study. I financed her study. She enrolled off line and in 2005 she went back to Ukraine for a month and passed her Master's exam and got a master's degree in languages. I financed and supported this one hundred percent. For next 2 years I supported her to study Law. She could not.

30. As of 2004 Alina had virtually zero work experience. In Ukraine, she worked barely 10 hours a month doing odd part time jobs as an interpreter - translator.

31. As of 2004, I had a Bachelor of Science degree from the National Defence Academy, a Bachelor in Electronics Engineering Degree and a Master in Computer Science Degree from the IIT. I had over 11 years work experience in the Army as an officer leading men, managing over a 100 men in my command. Since 1995, I had worked in major US corporations - Bankers Trust, Chase and Merrill Lynch and since May 1996 I started and was running a successfull high tech, intellectually challenging software services firm. From leadership and management point of view, it is extremely challenging for a small company to hire, train, retain, manage and lead software engineers.

32. I have a wonderful ability to teach, mentor, train. In my business, my business model has been to combine social work with business. I hire those out of work, who cannot find work because they don't have the skills, don't have the required level of expertise, or their skills are outdated. I then train them for 2 to 12 months. After completion of training we then identify clients who require our services - software development services. When at client site, I continue to mentor and guide the work of SpaceAge employees.

33. Since May 1996 SpaceAge employees have worked at several fortune 100 companies like Bank of America, Goldman Sachs, JPM Chase, Morgan Stanley, Merrill Lynch, Lehman Brothers, etc.

34. Since May 1996 I have trained and put back to work several hundreds --

software engineers having bachelor's degree, master's degree, many had a Ph.D., in Computer Science, two had a Ph.D., from Harvard; and I have also trained and put back to work 4 Professors, one was a professor of Computer Science. When SpaceAge employees are assigned to work at client project or at SpaceAge office, I mentored and guided their work.

35. When Alina and Viktoriya began working at SpaceAge, Alina especially had zero skills. Viktoriya had some skills in accounts and she did not speak English. I trained them to work as admin, accounts, recruiting and marketing staff.

36. MARRIAGE: In marriage, we marry a human being, not a parasite. The relationship in marriage is symbiosis, not parasitic. If both are equal in all ways, if both have same earning potential, both worked and earned equal salary, or, both were working and earning equal salaries but mutually decided one will be a stay-at-home dad or mom, only then when they divorce, they split marital assets 50-50.

# "Equitable", does not mean "equal".

37. In divorce each should get exactly or close to what one would have, if one was living alone or if both were in a business relationship.

38. We have two children EM, born March 2006 and VM born Aug 2009.

# **39. DEFINITIONS, ABBREVIATIONS:**

(a) **<u>Kidnap</u>**: Kidnapping is - taking any human being away from her loved one against her wish.

(b) <u>Kidnapping of Children</u>: A helpless, defenseless child who cannot defend herself, cannot speak for herself, removed forcibly from one or both parents is defined as Kidnapping of Children in the context of Family Courts, Child Protection Services, and the State.

(c) <u>Child Predator</u>: A Child Predator is anyone who preys on Children. Predators in Jungle or in the Human world always prey on those who are weak, who cannot defend themselves, who have no voice, who cannot speak for themselves. A Child Predator is anyone who exploits a child, abuses a child, inflicts emotional and/or physical pain on a child; causes directly or indirectly irreparable harm to a child. In our Family Courts, children are tortured and abused to a level that our family courts now qualify to be called the Child Predator Industry. A Judge's chambers are torture chambers for children and innocent parents.

(d) **Psychological Murder:** Psychological Murder is -- kidnapping the child and then deliberately in a premeditated, well planned manner destroying the poor helpless child's love for her father and teach her to hate her father. To give an analogy - it is like, imagine the human brain is like a computer; the love a child has for her father is a software program. Psychological Murder involves destroying the program - "I Love Daddy Software" - and installing - "hate daddy software". Judges, CPS, lawyers, psychologists and therapists work as a team to accomplish this.

(e) Security Act Title IV-D: In this complaint when I refer to Security Act Title IV-

D, I am referring to (a) subsections which provide incentives to the State government for collecting Child Support, i.e. for every dollar the State government collects in child support (child support money taken from one parent and given to the other parent), the federal government gives the state government some matching incentive i.e. funds move from federal account to State account. (b) I am also referring to subsections which provide incentives to Child Protection Services for every child removed from one or both parents and then moved, in most cases trafficked through the foster care and adoption system. The state government officials have "business meetings", setting up goals, quota, etc., to accomplish for the current year, next year and so on.

40. Serial Child Predators: Do we have the ability to think, what kind of a human being will inflict such incredible cruelty, evil, injustice and irreparable harm for life, on helpless, defenseless children. Will this be inaccurate to say - "our entire government, top-down, has become a serial child predator!"

41. At an <u>unprecedented</u>, <u>unstoppable and exponentially growing scale</u> we are witnessing - the <u>Psychological Genocide of Children and Parents</u>, and, <u>Moral Suicide</u> <u>of Judges</u>, those in government and those not in government who aid and abet the kidnapping and psychological murder of Children.

42. Attorneys like Tracy Julian, Judges like Terry P Bottinelli, David B Katz and Donald A Kessler (here in after referred by their initials TPB, DBK, DAK) are in full

control, and they blame it all on the litigants - "high conflict divorce, highly litigious, bitter custody dispute,..."

43. Almost in every crime, "MONEY" is the motive!

44. Show me one case where litigants had \$0.0 assets and earned less than \$30,000 a year -- and it was a -- "high conflict divorce, highly litigious, bitter custody dispute,..."

45. In EVERY "high conflict divorce, highly litigious, bitter custody dispute", --Lawyers like Tracy Julian from Pashman Stein Walder Hayden, walk away with millions of dollars. Tracy Julian has walked away with - <u>over \$3 million in less than 4</u> <u>years that she represented Alina Myronova</u>.

46. Out in the streets, a child predator kidnaps a child and demands a ransom - i.e. makes money off the kidnapping. i.e. money is the motive.

47. Every child predator working in and with the family courts <u>has the same</u> <u>motive - "MONEY"</u> - Family Courts, Child Protection Services, the State and all actors like family court lawyers, psychologists, therapists, etc., <u>for money they all aid</u> and abet to kidnap and traffic the child around.

48. Unlike on the street, kidnapping of children in Family Courts and Child Protection Services - <u>is very easy</u>. Based on a false alarm - multiple levels of hearsay, kidnap the child away from one or both parents and then order psychological evaluation and therapy for one or both parents and children, etc. After that, in every

case the situation has only gone downhill with the child being permanently removed from one or both parents, and in the process (for example in my case) the litigation has gone on for well over 11 years, the State has made (or will make) over \$3 million, the attorneys are making well over \$5 million and a parent like me at 62 years of age, has become a slave for next 30 years, lost an entire 40 years of blood, tears, sweat and toil; and ordered to pay another \$2.3 million over the next 30 years - i.e. **ordered into** 

### **Slavery for the rest of my life!**

49. <u>SCIENCE USED BY CHILD PREDATORS IN FAMILY COURTS</u>: Here is the "Science" that is used by Child Predators in Family Courts and Child Protection Services:-

(a) Any adult like me can be kidnapped and with a suitable duration and level of psychological and physical torture - easily be made to criticize, condemn - his spouse, mother, father, children, family, religion and country.

Child Predators use this insight brilliantly in kidnapping and psychologically murdering children and then telling the world that, "the children don't want their father (mother)".

(b) Any bird or human being can be kidnapped, put in a cage and with time the bird and human will come to terms with living in the cage, and with time even sing and play in the cage, - and then the Child Predator tells the world - "look the children are

singing, playing, happy,.. hence they are not in a cage (or perhaps they belong there)!"

(c) Child Predators know very well, any child, (lets say 4 year old) can be left in a jungle with the wolves or monkeys and then after 2 years, 4 years, 6 years, - that child (assuming she does not die of any disease) will learn to walk, talk, act and behave like monkeys (wolves (Feral Children)), and with time, such feral children will refuse to go back to the civilized world -- and then the Child Predator tells the world - "look the child does not want to go back to the other parent."

(d) Child Predators routinely kidnap children, deliver them to the wolves and then after a period of time justify, - "look, the children are happy, they are playing, they are doing well, hence living with the wolves is in their 'best interests', this is where they belong!"

(e) Secrecy, Power, Money and Lack of Accountability: the ultimate, most powerful recipe to transform human beings into devils, or to unleash the devil inside a human being.

(e) Secrecy breeds crime and corruption. Every evil person, every criminal, everyChild Predator demands absolute secrecy - Gag Orders.

(f) After Kidnapping and psychologically murdering children, Child Predator lawyerslike Tracy Julian then get the Judges to pass sweeping gag orders. The entireConstitution is flushed down the toilet. The poor helpless parent(s) are threatened,

silenced, sanctioned - they cannot tell their horrifying experience to anyone in news media or on social media. There is no "knee to the neck,.., choke hold" video anywhere.

50. Based on several criteria, parameters -- the case, Myronova vs. Malhan vs, SpaceAge vs. Myronova; Malhan vs. Myronova and Myronova - is one of the biggest in US Family Court history.

51. The outcome in this case is incredibly stunning, shocking - this is living proof of the, "State gone Rogue!" Or at best Tracy Julian has the State of New Jersey on a tight leash.

52. Lets analyze in how many cases - lawyers like Tracy Julian have allowed judges like - Judge Terry Bottinelli and Judge David Katz to award a child 50-50 parenting time with both parents; or even 80-20? Lets study the same in all family courts all over the State of New Jersey and all over America. What we are witnessing is absolutely horrifying.

53. A poor helpless 8 year old child is kidnapped away from her loving father she loved very dearly, and then the helpless child is forced to hate the color of her father's skin and disown him as her father - by one of the most accomplished child predator attorney Tracy Julian and these evil, cruel acts are encouraged and covered up by Judges - Terry P Bottinelli, David B Katz and Donald A Kessler (TPB, DBK, DAK).
54. A poor helpless 8 year old kidnapped child is forced by Tracy Julian - not to

look at her father, not to touch her father, not to hug her father, not to call her father "daddy". By doing so Tracy Julian earns well over \$3 million in legal fees and Tracy Julian helps the State of New Jersey <u>launder</u> well over \$2 million.

55. What is happening in family courts all over America is like a horror Science Fiction movie, and this horror is, real and life long for over 20 million children and parents. At least 50 innocent children added every day all over America! This is happening in all states all over America! For how long can this go on?

56. Every day at least a 50 children are kidnapped in family courts and then psychologically murdered - put through a slow drawn out, brutally evil psychological death.

57. What kind of psychopath will do this to innocent, helpless, defenseless children. What kind of people, in government and outside, will enthusiastically aid and abet such evil psychopaths.

58. How can any attorney general look at the family courts and everyone working in or with family courts, and tell them -"you can kidnap and psychologically murder children", and then expect of himself and all other government departments -"humanity, integrity!"

59. Based on just one family court case, how can the State move over \$2million from Federal Treasury to the State Treasury!

60. Based on just one family court case, how can the attorney Tracy Julian earn

over \$3million in less than four years!

61. How can attorney Tracy Julian influence a Judge to order that the legal fees of over \$2 million awarded to her, should be accounted in the State account books as "Child Support Backlog!" For what motive a Judge would do this? For what motive an attorney general would look the other way?

62. For what motive would any court - District Court, 3rd Circuit Court of Appeal or The Supreme Court of the United States of America - dismiss this complaint which is impacting over 20 million children and parents all over America and every day at least a 50 are added. Why will any court aid and abet this incredible inhumanity at such a colossal scale - which will cause the American Civilization to "self-destruct".

63. <u>Equitable distribution</u>: In marriage - the earnings and assets of two individuals get commingled. If and when they divorce we simply separate the commingled assets and give each what they put in. This is plain and simple. "Equitable" and "Equal" - are two different words! They have entirely different meaning.

64. This is the test of fairness. If the marriage lasted one year, then after divorce each individual should be allowed to take out exactly what they put in - and this would be pretty much same as when the couple had not lived together for the past one year i.e. had lived single by themselves.

65. Marriage is not a short cut to get rich quick. Marriage cannot be used for unjust

66. If I am earning \$50,000 per year (after tax), and I marry a billionaire for a year, then after divorce I should walk away with less than \$50,000 - factoring in money I would spend on living expenses if I had lived single. It is illegal and immoral for me to demand that my billionaire spouse support my "standard of living!" The only reason litigation is whipped up is because lawyers then make millions of dollars in illegal legal fees and if children are involved, the State also makes money via Social Security Act Title IV-D.

67. Successfully kidnapping and psychologically murdering my two innocent helpless children, -- for this great act of humanity, Judge Terry Bottinelli awarded that I pay Tracy Julian over \$2 million in legal fees, and Judge Terry Bottinelli ordered that this be accounted in State account books as "Child Support Backlog!" Why will any Court or any one in government or anyone outside government aid and abet such monumental inhuman crime. Such crime is done by psychopaths who are evil and cruel to the bone.

68. In a car sale show room, a car is listed for \$30,000. Why should I be forced to buy that same car in family court for over \$5 million? This is exactly what the family courts all over America are doing. All State governments are mandating this. Why should any divorce cost well over 11 long years in time and well over \$5 million in cash? This is the exact equivalent of the family court players selling the \$30,000 car

for over \$5 million and pocketing the money.

69. A house is supposed to be constructed in under 2 years, why should the Family Court force me into having my house construction drag on to a never ending 11 years hell.

70. There is absolutely no reason why the most complex divorce cannot be done in less than two years and in less than \$100,000 and the trial in well under 20 days.

71. This is happening in all cases all over America.

72. Why should any divorce last over 11 years and why should it result in all earning and all assets of both litigants wiped out, plus have one litigant (myself) plunged into over \$2 million in debt, i.e., at age 62, turned into a Slave to work for next 30 years to pay off this debt - and "all money going into the pockets of Tracy Julian." What motive does any Judge have to help Tracy Julian earn over \$3 million? What motive does the State have to aid and abet? Why will any human being, in office or out of office, aid and abet such inhuman, evil horrendous crime against children and parents. The government does not allow any bank, any financial institution or any business to even remotely commit such crimes.

73. Imagine a Judge has \$2million in assets and he goes to a bank financial manager and asks the bank financial manager to manage his \$2 million in various investments. What if after 11 long years the Judge loses all of the \$2 million investment, plus loses all his earnings over the past 11 long years, plus he is in debt

of over \$2 million. This bank financial manager will certainly be in jail. Tracy Julian and all her partners are boldly walking free!

74. I am 62 years old. I am a Slave. In February 2022 with the Judgement of Divorce, effectively, I have been sold in servitude to Tracy Julian from law firm of Pashman Stein Walder Hayden. Over 42 years of my blood, tears, sweat and toil, over \$2 million, - I have been ordered to hand over to Tracy Julian. And after that I need to work for next 30 years and pay her another \$2 million. In fact unofficially, I became a Slave when I entered the Family Court on February 24, 2011. Like a Slave, I have no right to my blood, tears, sweat and toil. There are over 20 million Slaves like me, enslaved by family courts all over America.

75. Like a Slave I have no right to my children and my children have no right to their father.

76. Like a Slave I have no right to any court and this complaint - will be dismissed.

77. All over America, we have over 20 millions victims of bone chilling,horrendous, inhuman levels of evil, injustice, crime and corruption. Victims of familycourt crime have zero access to the law, to our courts, to a fair trial.

78. What will happen when a Judge in family court knows, that his word is the final word and no higher court - State or Federal will hear the appeal.

79. A car salesman is paid \$1000 incentive for each car sold. Hence he tries to sell as many cars as possible.

80. Social Security Act Title IV-D has caused far more destruction than NRA and all special interest groups combined.

81. Social Security Act Title IV-D has destroyed at least 50 times more lives than the destruction caused by NRA and all special interest groups combined.

82. For every dollar collected in Child Support, the State of New Jersey is paid an incentive as per a sub section in Social Security Act Title IV-D.

83. As a result the State of New Jersey openly encourages all family court Judges, all lawyers practicing family law, all CPS/DCPP workers, all Psychologists,
Psychiatrists and Therapists and every one involved with family courts -- to aid and abet in the incredibly inhuman - cruel and brutal - kidnapping and psychological murder of children.

84. Can the State of New Jersey show the world, just one case, where in family court they have protected the rights of the victim child and parent.

85. Entering family court is like entering a city where there is no police, zero law and order - it is pure hundred percent - rule of the jungle, where mighty predators like Tracy Julian roam unrestrained - preying on children and the blood, tears, sweat and toil of victims.

86. Entering family court is worse than entering a river filled with Piranha's. The Piranha stops feeding on you when it reaches your bone. Family Court predators break the bone and feed on the bone marrow as well.

87. Entering family court is - "Entering the Gates of HELL!" From then on, for the children and victim parent - life is a Living Hell on Earth!

88. The perfect breeding ground for crime, corruption, evil and injustice is -

POWER, SECRECY, MONEY - GREED, ZERO ACCOUNTABILITY.

89. In family court lawyers like Tracy Julian, Judges and all players enjoy all these privileges - power, secrecy, unquenchable greed, zero accountability.

90. Money, Power, Secrecy, Lack of Accountability and then we have Social Security Act Title IV-D.

91. In family courts - lying, cheating, stealing, manipulating, preying on children is a daily way of life. There are so many gaping loopholes. (a) In family court there is no Jury trial. (b) Judge is the Law. (c) Judge can order that the Therapist,

Psychologist, Child Protective Services, etc., interview the child and parents. (d) There is no record, there is no recording. Therapist, Psychologist, Child Protective Services can make up anything they want. They easily manipulate the child. I have myself seen this happen several times. They ask leading questions, they never take down any notes, when the child is saying something that they dont want the child to say - they will cut the child off, etc. My children have told me several times (in a sad tone) "daddy, she did not let me speak, she cut me off..." (e) Later on the Therapist, CPS workers do not even testify in court. The Judge ensures they are not called in to testify and if they do, they lie unrestrained. 92. In court all discussions related to children is top secret. All reports by Therapist, Psychologist, Child Protective Services is top secret. All records are sealed. Often Judges just make it all up. In supervised visits the victim parent is not allowed to take any photo or video of his children. Victim parent is not allowed even one minute of private conversation with his child.

93. If we file an appeal in Appeals Court, there is a standard one-word reply -"DENIED!" The appeals court does not even bother to explain. If the victim files in Federal Courts - Denied! You appeal to Circuit Court - Denied! You file an Ethics Complaint - Denied! You write to the legislator, senator, congressman - no action taken, no reply! Social Security Act Title IV-D has added another impregnable layer of defense.

94. If a mom and dad walk into family court and say, "we earn the same and we agree to 50-50 parenting time, <u>then</u> (a) Child support is \$0.00. (b) Lawyers, psychologists, therapists, judges, etc., make no money. (c) The State makes no money (through social security act title IV-D).

95. When litigants come and stand in a family court, everyone's eye is on - (a) What assets do the litigants have? (b) What do they work as, what is their earning potential, how much do they earn? And then judges, lawyers, psychologists, etc., all work as a well trained team to take charge, take control over the litigants, steer the case in such a direction that (i) Money is sucked out from the litigants pockets, (ii)

All assets are sold/dissipated and (iii) The litigants work multiyear, year after year - feeding the feeding frenzy of this predatorial team of lawyers, psychologists, judges, etc.

96. Child custody, child support is the number one driver; and spousal support and equitable distribution of marital assets is the second.

97. In over 80% of the cases, children are taken away from the father because (a) This is easy to sell - "the father is bad". (b) In every conflict between a man and woman, the sympathy and support, instinctively goes to the lady.

98. The poor dads are beaten dead by an evil, cruel system. Then they call them, "dead beat dads". In 20% of the cases where mom's lose custody and have to pay child support, they too are beaten dead. But the phrase "dead beat mom", does not go well. And child support if often not enforced for the victim mom.

99. Child Support is important. <u>Parenting time is far more important</u>. All over earth there are millions of single parents raising children without child support because the other parent is no longer on earth. Look at COVID, how many children have lost one or both parents. There is no child support, nor any support from government. The government does not even give the deceased parent's social security and Medicare benefits to the child.

100. The body language of an ethical, honest, humane person is absolutely different from that of a person who is dishonest, unethical, evil, cruel and has zero empathy.

101. Since February 24, 2011, I have watched in 3 different counties in New Jersey (Hudson, Essex, Bergen), over 10 Judges, over 10 lawyers from 3 different law firms who represented Alina, over 25 psychologists/psychiatrists, over 6 therapists, over 15 DCPP workers, over 15 parenting time supervisors and one Guardian-ad-litem (GAL) Mary Ann Stokes. Of these, 3 psychologists and the GAL were like great grand father, great grand mother, but very disappointingly unable to overcome the evil forces of nature. Not one of them had the body language of a honest, humane, kind, compassionate, law abiding person. I saw pathological manipulators, liars - pure evil unleashed.

102. From 2013 till date, in at least six federal law suits in federal courts and in third circuit court of appeals I have seen the team of attorneys from the Attorney General's branch in the State of New Jersey - their work, their replies, what they wrote, what they said in court --- "makes me hang my head in shame!" What a grave harm they are blindly doing to themselves and their progeny!

103. Since February 24, 2011, I have also spoken with, read about - experience of victims, several dozens, certainly over a hundred. Every one is shell shocked, unable to wrap their hands around this -- "<u>how could my government do this to me</u>!" Everyone walks into the family court thinking, "I will see justice!", and every one is shell shocked to see psychopathic levels of evil, cruelty, injustice.

104. Millions made the ultimate sacrifice so we have our freedoms and we can

preserve our humane, civilized values. It will now be accurate to say that millions made the ultimate sacrifice so as several thousands of child predators can roam free and prey on millions of helpless, innocent children and parents.

105. We bought and sold slaves. We bought and sold slave children "to the highest bidder". We ripped of thousands of native children away from their parents into government funded and run schools, and hundreds perished without a trace. The same psychopathic level of bone chilling evil, cruelty, absolute lack of empathy - we now see in family courts and child protection services and all who work in or with them. So much of government time and money is spent on kidnapping and psychologically murdering children and defending predator lawyers like Tracy Julian. In my case alone I estimate the State of New Jersey has spent over \$5 million, and the attorneys working in the attorney general's branch have spent well over 1000 hours, defending child predator lawyers and judges in Federal District Court and in The 3rd Circuit Court of Appeals. I have watched and listened. My head hangs in shame - the arguments and write ups by lawyers in the Attorney General's branch - defending the State of New Jersey in District Court and in the 3rd Circuit Court of Appeals. I have seen first hand, up close, since 2013, the Attorney General working hard to cover up the crimes committed by the State - just so the State can earn money under Social Security Act Title IV-D.

## **MONEY LAUNDERING**

106. Judge Terry Bottinelli illegally awarded Attorney Tracy Julian illegal legal fees in excess of over \$2 million. In addition to this, Attorney Tracy Julian is collecting another \$1 million or \$2 million from her client Alina Myronova. In less than 4 years an attorney earning well over \$3 million in legal fees - <u>that can only happen through</u> <u>incredibly illegal and fraudulent means</u>.

107. After earning such a fee, the next challenge for Attorney Tracy Julian was-"how to collect?"

108. To collect Attorney Tracy Julian did three things.

109. Attorney Tracy Julian fully leveraged the incredible power of the largest most powerful law firm in the State of New Jersey - Pashman Stein Walder Hayden.

110. Attorney Tracy Julian coerced Judge Terry Bottinelli to award Alina Myronova an illegal astronomical share in marital assets - including a share in my <u>pre-marital</u> <u>and post-marital assets</u>.

111. If Alina were my "EQUAL" in her ability to earn money, then she can be given 50-50 in marital assets.

112. If we compare resume of Alina and Malhan, we are miles apart. Even in age and experience I am 23 years older. In 2004 Alina was still in college. Alina has education and experience as an interpreter translator. I have education and experience as a software engineer and in leadership, management and running a business.

Imagine President Donald Trump, if each of his ex-wives walked away with over 80% of his assets.

113. We don't need 100 days of trial. Just this fact is enough. Alina is 23 years younger, the relationship is only 6 years. <u>Based on this alone</u>, one can expect the man to get at least 75% of the marital assets unless the lady is a rock star and the man is a jobless drunkard.

114. Attorney Tracy Julian coerced Judge Terry Bottinelli to cover up all crimes of Alina Myronova - such as fraudulent documents, fraudulent bank statements, stealing of over \$300,000 from marital assets, unjust enrichment of over \$300,000, etc. If these crimes are not covered up then a honest Judge would order that Alina and Viktoriya pay me at least \$500,000 with interest.

115. Attorney Tracy Julian coerced Judge Terry Bottinelli to commit the ultimate jaw dropping crime. Judge Terry Bottinelli ordered that the State of New Jersey to account the \$ 2 plus million legal fees awarded (that I pay Tracy Julian) - be accounted in the State account books as "Child Support Backlog". As a result of this order, on the morning of 25 February 2022, I woke up to the stunning Breaking News! I owe over \$2.2 million in child support! To have \$2.2 million in child support backlog I should be a father of at least 30 children.

116. Let us understand what motive does the Judge has and, what motive the State has?

117. There are several motives!

118. The number one motive is - by accounting legal fees as child support in the State's account books, a matching amount of money will move from federal accounts to the State account under Social Security Act Title-IV-D. This is stunning - a sophisticated form of <u>Money Laundering</u>. This is illegal movement of Federal funds, this is stealing of federal funds.

119. Will any bank, private business or individual, be allowed to do such accounting? We all know very well, in past 25 years how many large banks, investment firms, mortgage firms went bankrupt, closed down- when they cooked their books and laundered money in ways that were much less illegal than what Tracy Julian caused the State Government to do through Judge Bottinelli.

120. Bernie Madoff cooked his books and laundered money. He was criminally charged and sent to Jail. Bernie Madoff masterminded the biggest investment fraud in U.S. history, ripping off tens of thousands of people of as much as \$65 billion. We now have the State governments in the US doing the same.

121. This is - Money Laundering, Cooking the Books! How can Tracy Julian and the Judge claim "Judicial Immunity!" How can every one who collaborated not be criminally liable!

122. A perplexing question I asked myself after the Judgement of Divorce dated 25Feb 2022 was: "The Judge has ordered me to pay attorney Tracy Julian \$2 million in

legal fees, but this has been accounted in State books as 'child support backlog', so 'how exactly will I be paying the legal fees - to Tracy Julian?' How will this work?" 123. After several weeks I figured this out. I will be paying the child support backlog, that money will then be given to Alina since legally it is "child support", Alina will then pass it on to Tracy Julian since this is legal fees awarded. <u>This is</u> <u>stunning</u>! This is illegal at several levels. I expect Tracy Julian will be having an agreement in place with Alina Myronova stating that when she receives such "child support" payments, she will pass them on to Tracy Julian.

124. And here is another super stunning, mind blowing thing. After all my assets are sold and Tracy Julian has pocketed all money, lets say I win on appeal and the State appeal court or State Supreme court or the Federal courts - reverse the decision of the trial court and order that all money I paid to child support as child support backlog be refunded back - then how will this work? Tracy Julian will not be responsible to return the money she pocketed. If Alina tells Tracy "return the money", Tracy will reply (to Alina) "well you have to pay me over \$3million in legal bills, if Malhan does not pay, then you have to pay, hence for me this money received via child support is legal fees <u>that you have paid me</u>!"

125. This illegal accounting practice and money laundering is happening in every family court all over America.

126. Such money laundering and accounting, -- reclassifying of "legal fees" as child

support -- if this was done in any financial firm or any firm, then that firm would be criminally liable just as Bernie Madoff was.

127. Since February 2011, I have seen with my eyes in my case and all over social media from experience of several dozens - such results are accomplished by a team comprising or one or more Judge, Lawyers, Psychologists, Therapists, DCPP workers, etc., and in all cases, the Attorney General looks the other way.

128. In early 2017, Pashman Stein Walder Hayden (PSWH) took over this case- i.e. representing Alina Myronova. For a year Robert Kornitzer from PSWH represented Alina and then Tracy Julian.

129. <u>Big law firms, make big money</u>. <u>Big law firms charge big money</u>. Rich and powerful people hire big law firms. In family law, the law firms know - their client's spouse's bank account is fair game.

130. Why will the largest most powerful law firm represent Alina Myronova - who has done marriage fraud, immigration fraud, stolen over \$300,000 from marital assets, falsified documents, etc. Most important - Why will the largest most powerful law firm represent Alina Myronova when Alina cannot pay multimillion dollars in legal bills?

131. This is not rocket science. This is happening all over America. PSWH can see the assets I have. Clearly the outcome of the trial was predetermined, else PSWH would not have taken this grave risk. So much so that even the settlement offer before

Trial and before the Judgement of Divorce - was the same, - that I hand over my 42 years of blood tears, sweat and toil to Alina (who then will hand it over to Tracy Julian.)

132. A lady still in college, with 6 years part time work experience, and 6 years relationship was awarded well over 80% of another persons 40 years of blood, tears, sweat and toil; and after that I am still in debt of over \$2 million - classified as Child Support Backlog! This was done only and only so that all this money finds its way into the pocket of Tracy Julian!

133. Everyone behind this wants the world to believe that this happens in an honest courtroom!

134. Such result can NEVER be produced in an honest court room.

135. Let us assume the award of \$ 2million legal fees to Tracy Julian was LEGALLY correct. Then why is it accounted in State books as "Child Support Backlog"?

136. Accounting \$ 2 million dollars legal fees, as "Child Support Backlog" is sufficient to prove that the award of \$ 2 million dollars legal fees is illegal, and then reverse engineering backwards - the award of over 80% of marital assets to Alina is gravely illegal.

137. There is serious conflict of interest. This calls into question - MOTIVE.

138. Illegal amounts of child support, leads to ENSLAVEMENT of innocent,

Malhan Federal ComplaintPage 32 of 104

honest, law abiding citizens.

139. We all know how many legislators supported insurrection openly. It is possible for legislators to enact laws for the benefit of few - laws that are unethical, immoral, unjust and unfair.

## **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff prays that this Court will:

1. Give its opinion explaining in detail - is this accounting practice legal? Can non government firms follow the same accounting practice.

2. Order an investigation, a study group to study and identify in each and every family court under its jurisdiction - list each and every case where legal fees or any other charges have been accounted as "child support backlog". Order that all Judges, law firms, lawyers, psychologists and victims be identified and listed.

# COUNT - 2

# ILLEGAL SEIZING OF FINANCES AND ASSETS

140. As per judgement of divorce (JOD) dated 25 February 2022, I am <u>not</u> <u>delinquent on my current child support payments and payment of arrears -</u> installments.

141. Despite this the State has seized my income tax refunds from both State and Federal.

142. As per JOD from sale of my rental property 5G at 10 Huron Avenue, I was

awarded 35%. The State has seized this money. Since I am <u>not delinquent</u> on my child support payments, the State cannot seize this money.

143. <u>What if Unit 5G was not sold</u>, <u>then would the State seize the asset</u>? Why should it become eligible for "seizing" only when sold?

144. A 100% relevant and accurate analogy is that of mortgage. As long as I am paying mortgage and I am not delinquent on mortgage payments, the mortgage company cannot seize any of my assets or seize any money from sale of any of my assets.

145. If the law says, Unit 5G cannot be seized, but if sold then money generated can be seized - then, a Judge passing the order to sell 5G, <u>has passed such an order with</u> <u>malicious intent</u>. A Judge cannot claim judicial immunity for such malicious intent. Tracy Julian forced the judge to pass this order.

146. This same illegal, malicious order has been passed for all 9 units I own - of which one is pre-marital - my residence and 2 are my office units - post marital.
147. As of this filing unit 12P is on sale and I am told under contract. I ask that my 35% from sale of this unit be given to me or applied towards my purchase of my residence and office units. I ask the same from the sale of unit 5G.

148. For over 7 long years Alina and her attorneys never claimed a share in pre marital and post marital assets. And then came the biggest, most powerful law firm PSWH which can bend light.

## **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff prays that this Court will:

1. Order the State to refund me all monies seized from Tax refund and from sale of units.

2. Money from Sale of unit 5G and 12P or my share in these units be given to me or applied towards my purchase of units 2L, 1M and 1N.

3. Further to above, in case I am unable to purchase my two office units, then my share in 1M be applied towards my purchase of unit 1N.

# COUNT - 3

# **LEGAL LAUNDERING - LAUNDERING LAW**

149. The judgement of divorce (JOD) dated 25 February 2022 will go down in history as an incredible masterpiece of laundering law - legal laundering. From beginning to end the 6 page JOD and 338 page JOD Opinion is filled with instances of laundering law.

150. Let us dare to ask ourselves: "what does this 338 page judgement of divorce accomplish?"

151. If we "<u>follow the money</u>", we will see that in the 338 page judgement of divorce, the primary goal is to ensure that Tracy Julian from the law firm of Pashman Stein Walder Hayden - the most powerful law firm in the State of New Jersey, can

collect over \$3 million in illegal legal fees. To accomplish this goal, <u>every law has</u> <u>been laundered</u>.

152. It will not be out of place to write here that - within weeks of writing the 338 page JOD, Judge Terri Bottinelli retired and he is now employed by a law firm, right across the street from the court - his new office is in the same building in which the law firm Pashman Stein Walder Hayden has a palatial office.

153. Family law judges, after retirement - employed by family law firms - is a serious conflict of interest - such practice is not allowed in any other industry, especially in financial firms.

154. Even retired Supreme Court of New Jersey Judge Gary Stein - a partner in the law firm Pashman <u>Stein</u> Walder Hayden, - is serious conflict of interest.

155. Every page, every paragraph in the 338 page judgement is an example of laundering law. Here below are few Examples of laundering law.

156. Example-1: Legal fees awarded to an attorney (Tracy Julian), Legal fees awarded to Law Firm, -- entered in account books of the State of New Jersey as "<u>Child Support Backlog"</u>. This is unheard of! This results in multiple cascading illegal and brutally evil effects.

157. On paper the share awarded to Alina is (a) 2L Premarital - 65%. (b) 1M, 1N - post marital - 40%. (c) 12P, 5G - 65%. (d) 10H - from sale of 10H all money converted to children's college fund and given to Alina. (e) 6J, 2C, 8A: (sold in 2017-

2019) over 70% went to Alina.

158. Into this if we take into account (a) all money stolen by Alina and Viktoriya.
(b) illegal spousal support. (c) illegal child support amounts. (d) illegal - premarital and post marital. (e) Unjust enrichment. (f) After all this I am \$2.2 million in debt.
etc. If we take all this into account then it will be fair to say, Alina on paper was awarded way over 100% of Marital assets, may be even 200% of the marital assets.
And again, this is only on paper. On ground, every penny awarded to Alina, given to Alina - found its way into the pocket of Tracy Julian.

159. Example-2: Illegally awarding Alina Myronova an illegal share in marital assets where she has negative equity. By doing so the judge can make it look legal - to order sale of such units. How can any lady still on college, after 6 year relationship with a person 23 years older be given 65% share in marital assets when she in fact has already stolen over \$300,000 from marital assets. Even if she had not stolen from marital assets, even in an absolute best case, most favored scenario - Alina cannot be given more than 50%. The 65% awarded to Alina goes into the pocket of her attorney Tracy Julian. All this, is a way of laundering, extracting money from my pocket and moving it into the pocket of Tracy Julian.

160. Example-3: Illegally awarding Alina Myronova an illegal share in my premarital and post-marital assets. By doing so the judge can make it look legal - to order sale of such units. This is illegal and incomprehensible that a person is awarded

share in assets from premarital and post marital assets. Here again, money awarded to Alina will go into the pocket of Tracy Julian.

161. Example-4: Accounting legal fees as child support backlog - opens the door wide open to <u>misinterpret</u> child support collections laws, where by - money from tax refund and from sale of properties, even though illegal, can be seized by probation - for child support backlog.

162. Example-5: Despite illegal equity share awarded to Alina Myronova, the Judge could have consolidated all equity share awarded - for example the Judge could have shown some humanity by saying, I can use my 35% share in marital assets and apply it on premarital (my residence) and post marital (my office) and there by prevent sale of my residence and office units.

163. Example-6: Judge wrote in JOD that for my residence I have the option to buy, I can buy out Alina's share of 65%. This was not the real intent. The Judge thought I would be so buried under debt and so broken down, that I would not have the ability to buy. Alina's 65% share amounts to about \$315,000. Since March 2022, from two banks I had an initial round of pre-approval to refinance 2L and buy out Alina's share. Tracy Julian and the Judge did not allow this. I then had a friend Manoj Kumar who made an offer to buy at \$490,000. Again Tracy Julian and the Judge did not allow. If this was allowed then the 35% my share will not go into the pocket of Tracy Julian. Same logic applies to why I am not allowed to buy / refinance one or both of my

office units. By seeing how the judgement plays out, we see the real intent of the person who drafted the judgement of divorce.

164. Example-7: By awarding Alina illegal share in all my assets, and accounting legal fees awarded as "child support backlog", the judge was laundering law to ensure that Tracy Julian is able to collect her legal fees.

165. Example-8: We know every criminal, every thief leaves behind some clues, some evidence. Same is true of this 338 page judgement. The fact that the share in equity awarded to me can be and is being seized by the State so as it can then be channeled to Tracy Julian shows that the intent of all this was to ensure that Tracy Julian collects the legal fees awarded to her.

166. For my residence the Judge ordered that I have option to buy out Alina's share.But then this is being disallowed. Why? Because if I buy then the 35% that should be seized by the State and diverted to Tracy Julian - is not possible.

167. Same applies to my 2 office units which are post marital assets and Alina is awarded 40% share. (a) Awarding Alina 40% in post marital asset, is ILLEGAL! (b) Judge knows - both Alina's 40% and my 60% -- i.e. 100% will go into the pocket of Tracy Julian.

168. Awarding Alina 40% in my 2 office units is an excellent example of evil,
illegal and inhuman intent. We can use simple 5th grade math logic to prove that -100% will go into the pocket of Tracy Julian.

169. If 100% will not go into Tracy Julian's pocket then, the \$2 million legal fees awarded to Tracy Julian will not be accounted in the State's account books as "Child Support Backlog".

170. If 100% will not go into Tracy Julian's pocket then, on 2L, the judge will allow me to exercise my option to buy.

171. If 100% will not go into Tracy Julian's pocket then, on my office units the Judge will allow me to buy out Alina's 40% share in my office units (post marital asset).

172. If 100% will not go into Tracy Julian's pocket then, on my marital units Alina will not be given any more than 50% and I will be allowed to apply that against my residence and office units.

173. Please may I know what law, what humanity compelled the judge to pass such an extraordinary order that I cannot apply my share of equity in all units to offset Alina's share in equity in my residence (pre-marital) and office units (post marital). This is absolutely incomprehensible. The only fact that helps us understand this is that 100%, my share and Alina's share in all properties - after sale, will go into the pocket of Tracy Julian, and to ensure that this happens, the legal fees awarded to Tracy Julian is accounted for in State account books as "Child Support Backlog". 174. The next logical question is - "why will attorney general of State of New Jersey" look the other way? Why will he allow such gravely illegal and inhumane Security Act Title-IV-D. And there are several more reasons as well.

## PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays that this Court will:

In the interest of justice, order a team of legal experts to study the 6 pasge JOD and
 338 page JOD Opinion and rule if our laws were laundered or not.

2. In the interest of justice, study the evidence presented in trial, the exhibits, trial transcripts; and compare with the 338 page judgement, and write a detailed opinion if what I have written has any merit.

## COUNT - 4

# **CONFLICT OF INTEREST**

175. Within weeks of writing the 338 page JOD, Judge Terri Bottinelli retired and he is now employed by a law firm, right across the street from his court office - his new office is in the same building in which the law firm Pashman Stein Walder Hayden has a palatial office.

176. Family law judges, after retirement - employed by family law firms - is a serious conflict of interest. Such practice is not allowed in any other industry.

177. Retired Supreme Court of New Jersey Judge Gary Stein - is a partner in the law firm Pashman Stein Walder Hayden. This is serious conflict of interest.

178. A common argument given is for example - Judge Bottinelli did not join

Pashman Stein Walder Hayden, he joined another law firm ABC whose attorneys did not appear in his court. This is not uncommon -- for Pashman Stein Walder Hayden to do a return favor to the law firm ABC.

179. After kidnapping of children away from one or both parents, the Judge then ordered "supervised parenting time". As per law this should be in courtroom by court staff - from the supervised visitation department. The law firm of PSWH and Judges like David Katz - hire same individuals / staff from the state court's supervised visitation department to supervise parenting visits privately outside the court and be paid for this by the victim parent. Maureen Grippo worked in Bergen County Court in the supervised visitation department. Out of 8 billion people on earth, Tracy Julian / PSWH and the Judge permitted only Maureen Grippo to supervise my parenting time for the next one year -from Sep 2017 to Sep 2018 - about 2 hours on a weekend about 2 times in a month. This is conflict of interest. All actors benefit from such supervised parenting time which is managed in a way so as to accomplish this goal to wean the child, brainwash the child away from the parent.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff prays that this Court will:

1. In the interest of justice, order a team of legal experts to study and rule if Judges after retirement are employed by a law firm, then that will not constitute conflict of interest.

2. To study, catalog list of all family court judges in past 10 years, which firm employed them after retirement, and the lawyers / law firms that practiced in their court.

3. In the interest of justice, order a team of legal experts to study and rule if court staff are ordered to work as parenting supervisors, then that will not constitute conflict of interest.

4. Order that a team studies, investigates how many times PSWH has hired court staff or any other individual as parenting supervisor outside of court and in how many cases did this result in severing of relations between parent and child. Such an investigation may find that in 100% of such cases the relationship between parent and child was severed and the law firm made millions of dollars.

5. Order that a team studies, investigates how many times an outside firm has been employed for supervised parenting time.

#### COUNT - 5

#### **GAG ORDERS**

#### FLUSING OUR CONSTITUTION DOWN THE FAMILY COURT TOILET

180. In family court we don't have our constitutional rights, human rights, children's rights. A parent does not have any right to parent his child, and, a child has no right to the love and care of her parent. Children are kidnapped away and then the parent is threatened with jail time if he speaks with the media or posts on social media.

181. Since 24 February 2011 I have been watching with horror as have millions all across America, - in family courts all over America, our Constitution is flushed down the family court toilet.

182. With horror, I have seen - no court, no attorney general, governor - has the humanity and courage to defend our Constitutional rights, human rights, children's rights.

183. In January 2020 in a motion hearing in the court of Judge David B Katz, attorney Tracy Julian took this to a whole new level, I think unheard of in the history of any democracy or any civilized society.

184. Family law lawyers like Tracy Julian kidnap children away from one or both parents, after that several cruel, evil, illegal acts are committed, one of which is to deny all contact between the parent and the child. A parent can go visit his child in the school, attend school activities hence pass a gag order to prevent that as well.
185. As of 2017 when my son and daughter were studying in Soaring Heights Charter School in Jersey City, there was no gag order. I was able to attend school events.

186. In 2020, after my son was applying for and later given admission in a private high school in the State of New Jersey (and a year later even my daughter), during the motion hearing on January 30, 2020 in the court of Judge David B Katz, I watched attorney Tracy Julian yell at the judge angrily as if the Judge works for her; Tracy

Julian angrily yelled words to the effect - "Judge sanction Malhan \$10,000 if he tries to contact any employee of any private high school in the State of New Jersey, directly or indirectly; \$10,000 for first offence, \$20,000 for second, \$30,000 for third offense and so on."

187. I still remember sitting in the court - Jan 30, 2020, as Tracy Julian yelled out these words. I thought she was simply venting, there is no way a Judge will pass such a **bizarre** order.

188. Later same evening or next day I got a hard copy of the order - I was stunned, how on earth could any judge pass such an order. A Judge in the United States of America, in one of the most civilized nation on earth in the entire history of human race, has passed such an incomprehensible, inhumane, illegal order and shredded our constitution and flushed it down the family court TOILET!

189. More shocking is that federal courts and 3rd circuit also were utterly helpless utterly lacking in courage, humanity and clarity. If this state of affairs continue, then God also will not be able to help America from self-destructing itself.

190. <u>How do we explain this</u>? In Jan of 2020 my son and daughter were studying in Soaring Heights Charter School (SHCS), my son was in 8th grade and my daughter in 5th grade. My son was applying to various high schools. There was no gag order restricting my visits to SHCS but a sweeping gag order was passed that I cannot speak with any employee of any private high school in the entire State of New Jersey.

This is bizarrely irrational.

191. <u>How do we explain this</u>? In September of 2020, my son joined Delbarton High School, my daughter continued at SHCS, there was no gag order restricting my visits to SHCS but the gag order stating that I cannot speak with any employee of any private high school in the entire State of New Jersey - continued.

192. The incredibly irrational, bizarre nature of the gag order is enough proof in itself about the evil, illegal practices in our family courts.

193. On this gag order, there is now a new situation and with this new situation comes new opportunity, a second chance - the district court, the state's attorney general and the 3rd circuit has an incredible opportunity, a second chance to redeem itself, to right an incredible wrong.

194. Recently I published a book Wisdom of the Ages. This book is based on my experience studying and guiding the mental, moral, psychological and intellectual development of children and young adults since 1977 -- with a focus on challenges Earth and the Human Species is faced with.

195. This book is specially for children 10 years and older. I have written it in a manner that children 10 years and older will benefit the most.

196. This book is for any living being who has human genes - from children to grandparents.

197. Considering all the challenges our planet and we human beings are faced with,

I think, this book is an important, must read book.

198. I am distributing as many copies as I can for free to various schools and colleges. Money I earn from sales will be used to fund our work at -- www.MeTooChildrensRights.org.

199. I am providing to this court a pdf copy of the book.

200. Judge, I humbly request you to please read the pdf copy of the book and present it, email it to a "private high school in the State of New Jersey".

201. I have been mailing hard copies and pdf copies of the book to the President,

First Lady, Vice President, Second Gentleman, Attorney General Merrick Garland,

Governor of the State of New Jersey, First Lady of the State of New Jersey, Lt.

Governor, Attorney General - State of New Jersey, all Senators, members of

Congress, Prime Minister of Canada, Prime Minister of UK, Heads of State - France, Germany, etc.

202. I have been requesting them to read and present the book to a school, and also present it to a high school in the State of New Jersey.

203. I will reach out to schools delivering lectures on topics as listed in this book.

204. In time, I expect Schools may reach out to me, inviting me to speak.

205. I want to offer my services as part time teacher to teach computer science,

computer programming, software engineering - to private high schools in State of New Jersey.

206. As per Tracy Julian and Judge Terry P Bottinelli and Judge David B. Katz - (a) the book I published is banned in all private high schools in the State of New Jersey.(b) Directly or indirectly I cannot mail a copy of my book to any private high schools in the State of New Jersey. (c) If any private high school in the State of New Jersey invites me to speak on any topic, I am legally debarred. (d) I cannot seek any part time or full time job with any private high schools in the State of New Jersey.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff prays that this Court will:

1. Provide a detailed opinion, justification, explanation how the gag order upholds our constitution, our freedoms, human rights, parenting rights.

2. Provide a detailed opinion that this gag order was passed by Judge David B Katz -- the Judge has impeccable integrity and humanity.

Provide a detailed opinion that this gag order demanded by an attorney Tracy
 Julian from the law firm of Pashman Stein Walder Hayden- the attorney and the law
 firm has impeccable integrity and humanity.

4. Order an investigation - to study all cases the Judge and the law firm has worked on, in how many cases (a) the child was kidnapped away from one or both parents.

(b) in how many cases the child was allowed to see the victim parent. (c) How much money the lawyers and law firm made in each case.

5. State reasons if I can directly or indirectly give the Book Wisdom of the Ages to

private high schools in the State of New Jersey.

6. Clarify, if the President, First Lady, Governor, First Lady of State of New Jersey, Attorney General Merrick Garland, Attorney General State of New Jersey, etc., if any one were to give this book to any private high school in the state of new jersey then am I in violation of the gag order.

8. Clarify that I cannot ask Prime minister of Canada to give the book Wisdom of the Ages to any private high school in the State of New Jersey.

9. Clarify - that no private school in State of New Jersey can invite me to speak on any subject.

10. Clarify that I cannot seek any part time teaching job at any private high school in the State of New Jersey.

# **COUNT - 6:**

# I AM A SLAVE!

207. In our family courts all over America, we are seeing immeasurable, palpable levels of cruelty, inhumanity, evil and injustice -- the kind we see in people like Hitler, Stalin, Putin, Saddam, Kim Jong-un, etc.

208. After getting her Green Card, Alina Myronova filed for divorce on 24 February2011.

209. I will be 62 years old in September 2022.

210. I am a Slave because for next 30 years, I have no right over the fruit of my

blood, tears, sweat and toil. Over 75% of my earnings will be extracted away from me in the name of child support and child support backlog - the entire money through the backdoor flowing into the pocket of attorney Tracy Julian.

211. I am a Slave because for next 30 years, I don't have the freedom to travel, I cannot have a passport.

212. I am a Slave because like a slave, I cannot parent my children and my children cannot see their father.

213. I am a Slave because of sweeping gag orders passed - (a) I cannot write on social media that I love my children. (b) I cannot speak with any employee of any private high school in the entire state of new jersey.

214. In one of the most civilized nations on earth in the entire history of human race, under what circumstances is such a gag order warranted - that a father cannot speak directly or indirectly, with any employee of any private high school in the entire state of new jersey because my son is studying in a private high school.

215. How can such a father then be considered fit to pay \$7260 per month in child support and pay over \$2 million in alleged child support backlog.

216. There is a very simple explanation on how illegal, evil and cruel this is.

217. Assume Alina was not a fraud and she did not file for divorce. Then would I be spending on my children \$7260 per month? In past 11 years, would I have incurred a child support backlog of \$2 million - i.e. would I have spent \$2 million on my

children in past 11 years?

218. Since filing of divorce I was paying \$3000 per month in child support and another \$3000 per month in spousal support. If we were not divorced would I have spent such an amount on raising my children and supporting my wife? The entire family was spending less than \$2500 per month.

219. And in the final analysis -- till date where did all this money go? And in future, where will all this money go? Into the pockets of attorneys like Tracy Julian and some bones going to psychologists, therapists, etc., like Dr. Paul Dasher, Kristen Luzzi-Odorisio, etc.

220. With the Judgement of Divorce on February 25, 2022, it dawned on me that unofficially I became a Slave the day Alina filed for divorce - February 24, 2011. Beginning February 24, 2011, I lost all rights to over 70% of my earnings.

221. <u>Degree of enslavement</u> - is the degree to which a person has been enslaved.
100% of my current assets are ordered to be been taken away. And after that I am still
\$2 million in debt - alleged "child support backlog".

222. <u>Duration of enslavement</u> - this is the time it will take for me to buy my freedom
i.e. payoff the alleged illegal "child support backlog" of \$2 million. At my current
earnings it will be 30 years, that means there is a good chance <u>I will die a Slave</u>!
223. As per Tracy Julian a "Family Court Judge's Order" is like an Order by God
from Heaven. If we study and interpret the orders from Judge David Katz and Judge

Terry Bottinelli we will infer that (a) Tracy Julian is a saint. (b) Surender Malhan is a monster - his children should not look at him, should not touch him, should not call him "daddy".

224. As per Tracy Julian, as per the 6 page JOD and 338 page JOD opinion, (a)Tracy Julian is a saint. (b) Surender Malhan is a monster!

225. If Tracy Julian can be proclaimed a saint, then any Family Court Judge in the United States of America can cleanse the sins of psychopaths and Order that Hitler, Stalin, Saddam, Putin, and all psychopaths are saints and any one not considering them saints will be gagged / sanctioned! This is not a joke. If we correctly interpret and apply all orders, effectively Tracy Julian is a saint and I have been gagged / sanctioned if I say she is not a saint.

226. And as per the final order - Judgement of divorce (JOD) dated February 25, 2022, officially I am a Slave and Tracy Julian is my Master! In the months since Feb 25, 2022, several times Tracy Julian has petitioned the family court that I be jailed because I am disobeying her i.e. the JOD.

227. Since January 2011 Viktoriya has been jobless, she has been unable to find work.

228. After filing divorce after her unemployment ran out, Alina began working and she has been working as a Recruiter in the Information Technology industry - a skill that I trained her at SpaceAge. Alina's education is in languages - Ukrainian, Russian,

German and English. Based on Alina's education she would get some part time jobs as an interpreter - translator - which she did try to find after divorce for herself and her mother but could barely earn anything from it.

229. So the six years Alina lived with me, she did not lose any thing in any way, shape or form, rather she benefited - enhancing her skills, employability and financially through unjust earnings, unjust enrichment. Hence by law she should get \$0.0 in spousal support.

#### 230. <u>Has this ever happened in the entire history of human race in any family</u>

**court**? That after a mere 6 year relationship with a lady from Ukraine 23 years younger, -- a 62 year old has been (i) robbed of his 42 years of blood, tears, sweat and toil (ii) illegally placed into a \$2.3 million illegal child support backlog debt (iii) ordered to pay \$7260 per month in child support (iv) my children illegally taken away (v) I am evicted from my residence - ordered that my residence which is a premarital asset to be sold (vi) my business is evicted -- the 2 units that house my office be sold (vii) and all this money, going into the pocket of attorney Tracy Julian and -- consider such facts, factors, conditions, environment, circumstances, etc.:-

- (a) Alina and her mother Viktoriya arrived in US from Ukraine with mere 2 hand bags, all expenses paid by me.
- (b) Mere Six years relationship.
- (c) Alina is 23 years younger to me, her mother Viktoriya is one year younger

to me.

- (d) If they lived by themselves, if they worked else where, they would be lucky to get a job and in the best case scenario together, they would have earned and saved barely \$20,000 in six years.
- (e) Alina was not a home-maker. Alina was not a stay-at-home mom. She virtually never cooked for me. She virtually did nothing that a wife typically does for her husband.
- (f) I took on the more challenging parenting responsibilities and devoted far more time to my children.
- (g) For their ongoing education, I encouraged Alina and Viktoriya, supported them and paid for their tuition and all education expenses - I estimate, I paid over \$70,000.00.
- (h) In 2004 when Alina arrived she only had a Bachelor's degree in languages.
   I encouraged her and paid for her Master's degree in languages from
   Kharkov University in Ukraine. After that I paid for her TOEFL and LSAT
   coaching classes and exam, and for applying to over 20 law colleges all
   over America.
- (i) I gave them a break, I gave them the big thing called "opportunity", I mentored them, taught them new high paying skills required in the IT industry. I paid them salary four times over.

- (j) In winter of 2006, Alina was expecting her employment based green card from SpaceAge, and in anticipation that her green card from SpaceAge can come any moment, she was insisting that we "separate without taking any divorce" - because we were not legally married then. When Alina's green card did not come (Dec 2006), overnight her tantrums stopped.
- (k) In March 2008, when Alina did not get her employment based green card, only then Alina agreed to get legally married.
- Over six years, both mother and daughter stole over \$300,000 from marital assets and stole over \$100,000 from SpaceAge funds, and working in SpaceAge unjustly enriched themselves with over \$400,000.00
- (m) Alina contributed \$0.00 to any marital asset. Alina contributed \$0.00 to any household expense. Alina paid zero bills. Alina stole over \$300,000 from marital assets. Alina was working in my business and was paid 4 times over. Alina virtually never cooked for me. I spent much more time than Alina taking care of my children. Alina's mother too virtually lived for free all her expenses paid by me her residence provided by me.
- (n) Alina and Viktoriya have whited out bank statements to which Alina has admitted only because she was caught red-handed i.e. we got the bank statements from the bank.
- (o) Alina and Viktoriya have forged my signature and during trial produced

these forged documents - exhibit P630. It is very easy to prove this since on 3 different pages/documents they produced -- (i) All 3 signatures are identical. No body can sign multiple times and have any two signatures 100% identical. (ii) All 3 signatures are exactly at the same spot on the paper - we can verify this both in terms of the parking spot on the paper and its relative position from the place where my name is typed "Surender Malhan". (iii) My name is typed "Surender Malhan". To this day in all business documents, I have always written my name as "Capt. Surender Malhan". (iv) These 3 and all other documents are not on SpaceAge letter head. I always write only on SpaceAge letter head. (v) The vocabulary, phrases in these fraudulent documents - are not my at all.

- (p) In 2016 Alina filed a false DV/TRO case and after a 9 day trial spread over 6 months, Judge Vito Sciancalepore ruled that "Alina is an incredible liar, she has admitted to felony, and based on evidence presented to court Malhan is justified in thinking Alina did marriage fraud." During trial Tracy Julian forced Judge Bottinelli to void this out 100%. There has to be some form of "force". Why will any Judge willingly rule that, "Judge Vito Sciancalepore was 100% wrong!"
- (q) Alina lied to grand jury in February 2017.
- (r) How can a divorce take 11 long years and even after that the milking does

not stop.

- (s) How can any trial take "100 long days" spread over two long years.
- (t) To file an appeal, court transcripts are mandatory. The cost of transcripts for 100 days of trial is estimated at \$130,000.00.
- (u) If a litigant cannot pay for transcripts then by law the State should pay. The state of New Jersey refuses to pay i.e. I am denied due process.
- (v) Is this a mere matter of chance, or a deliberate malicious intent to engineer the judgement of divorce in a manner that I cannot appeal. This is another example of legal laundering, laundering law - to ensure that I am denied due process.
- (w) Making a litigation go multiyear and the trial drag on for several months so the victim litigant will not be able to pay for transcripts and hence will not be able to file the appeal! This is happening in virtually every case all over America.
- (x) Why will any family court Judge or any lawyer like Tracy Julian who walked away with over \$3 million in illegal legal fees have such a malicious intent?
- (y) Tracy Julian and her law firm began representing Alina in early 2017. How can any attorney earn over \$3 million and counting, in less than 4 years though honest means.

- (z) How can any father lose custody and be given zero parenting time, but be ordered to pay \$7260 per month in child support and pay over \$2.3 million in child support backlog?
- (aa) How can any child be forced not to touch her father, not to look at her father, not to call her father "daddy", to tell her father "you are not my daddy"!? This is unheard of in human history. If we have a drop of humanity in us, it will make our blood boil!

## **PRAYER FOR RELIEF**

WHEREFORE, Plaintiffs pray that this Court will:

1. Legalize enslavement of innocent parents in the family court industry.

Or in the alternative, order an investigation into the illegal, evil, inhumane, brutal, uncivilized practices that lead to enslavement of parents, in all family courts under the jurisdiction of the third circuit.

2. Order a study group to study the legal practice of attorney Tracy Julian and law firm of Pashman Stein Walder Hayden, the techniques, tricks they use that leads to enslavement of respectable, law abiding citizens.

3. Only if the court encourages such inhumane, barbaric practice in all family courts all across America, only then I ask this court to dismiss this count with prejudice.

4. If this District Court is not the right venue, than I ask the court to rule, in which court should I file this case.

#### **COUNT - 7:**

# MORAL SUICIDE OF JUDGES. PSYCHOLOGICAL GENOCIDE -KIDNAPPING AND PSYCHOLOGICAL MURDER OF CHILDREN. DESTROYING AMERICA DESTROYING THE AMERICAN CIVILIZATION

231. Lasting Peace, Progress, Prosperity is built on a foundation of Integrity.

232. If we want Lasting Peace, Progress, Prosperity then we have to be Ethical,Moral, Just and Fair!

233. We have brought forth a Civilized Nation through the Blood, Tears, Sweat and Toil of millions.

234. Child Predator Law (Security Act Title IV-D) will go down in human history as one of the most insanely evil law, which will make a civilized nation "Self Destruct".

235. Social Security Act Title IV-D which incentivizes kidnapping of children – is one of the most evil, cruel, self-destructive piece of legislation in Human History. Already Judges enjoyed incredible protection and then here comes Social Security Act Title IV-D after which now everyone in this child predator industry enjoys absolute total protection! Under such protection everyone in the child predator industry has taken – evil, injustice, cruelty, crime and corruption to a whole new level to a level that is as terrifying as living in North Korea or in a Nazi Germany
 Concentration Camp.

236. For those entering the Family Courts life becomes a living hell, it is like entering the Nazi Concentration Camp. Family court judge's chambers are "torture chambers" for innocent helpless children and parents. I have watched helplessly, my children being kidnapped and psychologically murdered, and in the process attorney Tracy Julian and law firm of Pashman Stein Walder Hayden made well over \$3 million in less than 4 years.

237. How can any attorney general, governor, congressman, senator - tell a family court judge through silence that speaks louder than words: "I want you to continue your work as a child predator!" And then the same attorney general, governor, congressman, senator, - will expect of himself and his department and all other government departments - honesty, humanity, integrity!

238. Practically every therapist, psychologist, psychiatrist, mental health worker has aided and abetted family court and CPS child predators. How then can such a therapist, psychologist, psychiatrist, mental health worker - ensure the mental health of children and adults!

239. From February 2011 till date I have interacted with well over thirty therapists, psychologists, psychiatrists, mental health workers, Child Protection Service workers.I can't think of a single person who had honesty, integrity, humanity and courage to

do the right thing.

240. This is not rocket science. I have spoken with several people in all walks of life. Recently I spoke with the USPS mail delivery man. Even a person with his experience and intellect understood this right away and expressed deep shock that (a) the State government is paid an incentive by federal government for collecting child support, and, (b) the \$2 million in legal fees I have been ordered to pay Tracy Julian is accounted in State account books as "Child Support Backlog" so as to facilitate laundering of federal funds under Social Security Act Title IV-D.

241. United States of America, is the most civilized nation on Earth in the entire history of the human race thus far.

242. Social Security Act Title IV-D subsections incentivizing kidnapping and psychological murder of children - has in recent 20 years made the United States of America, the biggest Child Predatory Nation on Earth in the entire history of the human race thus far, AND the only nation where the government has masterminded and executed down to the minutest detail, the kidnapping and psychological genocide of children and, theft and money laundering of over \$2 billion dollars every year.
243. I can't think of any Dictator government which has done this to its own citizens.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

 Declare that Social Security Act Title IV-D subsections which incentivizes kidnapping and psychological murder of children, (a) is a serious threat to American Civilization, (b) is one of the most insanely evil law, which will make a civilized nation "Self Destruct.

2. Order that no - government or non governmental agency or individual benefit financially - directly or indirectly from Social Security Act Title IV-D subsections which incentivizes kidnapping and psychological murder of children.

3. Order a study group to study the ingenious practice of attorney Tracy Julian and her predecessor Robert Kornitzer - that lead to kidnapping and psychological murder of innocent children. Tracy Julian and Robert Kornitzer have perfected this practice like very few other lawyers have.

4. Only if the court encourages such inhumane, barbaric practice in all family courts all across America, only then I ask this court to dismiss this count with prejudice.

5. If the District Court is not the right venue, than I ask the court to rule, in which court should I file this case.

# **MY CHILDREN'S PHOTO**

244. I am paying \$7260.00 per month towards child support. I have over \$2 million in child support backlog to pay.

245. I asked judges in family court for a recent photo of my children. My request

was denied by Tracy Julian. The Judges stood by Tracy Julian's stand.

246. I asked for my children to be allowed to see their father's photo. My request was denied by Tracy Julian. The Judges stood by Tracy Julian's stand.

247. I asked for a child's right to at least "look at her father" when he is standing mere 2 feet from her. This was denied.

248. I asked for a child's right to call her father "daddy". This was denied.

249. I asked for a child's right to touch her father, to hug her father. This was denied.

250. I asked for a child's right to have a 10 seconds phone call with her father. This was denied.

251. All this will make one think, -- are we living on a Planet of the Child Predators!

# **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Allow a father a recent photo of his children.

2. Allow my children to see a recent photo of their father.

3. Allow my children to look at their father.

4. Allow my children to call their father "daddy".

# COUNT - 9

# TORTURE CHAMBERS FOR CHILDREN AND PARENTS

252. Our Family Courts are the equivalent of Nazi Gas Chamber, Torture Chambers- for helpless, defenseless children and their parents.

253. The cruelty, evil, brutality, inhumanity in family courts is "PALPABLE!"

254. Mark Twain said, "Man's inhumanity to man is tragic and lamentable!" Perhaps he referred to slavery. At times I wonder what would Mark Twain say about family courts.

255. One small yet incredibly sadistic example is - after kidnapping the children away through raising a false alarm, and after that -- in supervised visits children are forced by attorneys like Tracy Julian, not to look at their father, not touch their father, not to hug their father, not to call their father "daddy". Judges like Terry P Bottinelli, David B Katz and Donald A Kessler (TPB, DBK, DAK) - encourage lawyers like Tracy Julian in such inhumane, cruel, incomprehensible evil acts.

256. Can we stop, pause, for a minute visualize "I am an 8 year old child, what will someone have to do to me so I will say to my loving father - 'you are not my daddy', how will I feel?"?

257. In various grades and shades, this is happening all over America. To each victim, his level of pain is unbearable!

258. In supervised visits, for 60 long minutes, a helpless 8-year-old child is 2 feet from her beloved father and she is forced not to look at him, and act as if he did not exist. And then the kidnappers say - "everyone has to go for individual therapy, then collective therapy, etc." This is such a twisted form of psychopathy!

259. These are incredibly bizarre and very cruel, sadistic acts brought about by a team of judges, lawyers, psychologists, therapists, supervised parenting time staff and people all the way up to the attorney general.

260. What is the motive? The State makes millions of dollars moving federal funds to the state treasury; and the lawyers, psychologists, etc., make a lot of money.

261. The apex predator - attorneys like Tracy Julian makes the most - several millions of dollars.

262. I have asked for a mere 10 seconds video call with my children. Tracy Julian denied it and Judge Terry Bottinelli backed her up.

263. I have asked for a recent photograph of my children. Tracy Julian denied it and Judge Terry Bottinelli backed her up.

264. I have asked for my children to be allowed to see a recent photograph of their father. Tracy Julian denied it and Judge Terry Bottinelli backed her up.

265. As a result, in my case alone, over \$3 million has flowed from federal funds into state treasury and over \$5 million has flowed out from both litigants pockets - over 90% going into the pocket of Tracy Julian.

266. If children are allowed unsupervised parenting time, if children are allowed to hug their father, call their father "daddy", then moving these millions of dollars around - will NEVER be possible.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will: 1. Study the court transcripts and all evidence presented during trial and conclude if this was a humane and legally correct thing to do - to force Malhan children, not to look at their father, not to hug him, not to touch him, not to talk to him and not to call him "daddy".

2. I ask the court to offer an opinion that the family court was justified in not allowing Malhan children to have a 10 seconds video call with their father.

3. I ask the court to offer an opinion that the family court was justified in not allowing Malhan children to have a photograph of their father.

4. I ask the court to offer an opinion that the family court was justified in not allowing Malhan to have a photograph of his children and not allowed to have a mere 10 seconds video call with his children.

5. Only if the court encourages such inhumane, barbaric practice in all family courts all across America, only then I ask this court to dismiss this count with prejudice.

6. If the District Court is not the right venue, than I ask the court to rule, in which court should I file this appeal.

#### **COUNT - 10:**

# **IRREPARABLE HARM AND CRUELTY TO CHILDREN**

267. I have been studying and guiding the mental, moral, psychological and

intellectual development of children since I have 17 years old.

268. In physically violent crime, there are physical injuries. In family courts and CPS we see psychologically violent crimes. The psychological injuries on both parents and children are profound.

269. Childhood psychological injury / trauma - has very profound impact on the entire life of a child. This can change the entire trajectory of a child's life for the rest of her/his life on the planet.

270. Those inflicting trauma on children and parents - are destroying America and they are the doing the same what terrorists and enemies of the State do.

271. After Alina ended her scam relationship on Feb 24, 2011, I was deeply concerned about what morals, what character my children will grow up with. From June 2012 to 8 Sep 2017 I had my children 4 days a week on weekdays.

272. For building their intellect and integrity, I encouraged then to read books on a wide range of subjects - including biographies of great men and women -- all age appropriate.

273. In 2016, my 10-year-old son, was reading a book (short biographies of great men and women), he paused, got up, walked up to me and enthusiastically said: "daddy, I like this quote by Horace Mann - 'Be ashamed to die, if you haven't won a victory for humanity'." A 10-year-old boy can understand what it means to be "human"! 274. On Tuesday 8th March 2016 evening, my daughter Roma who was then 6 years and 7 months old walked up to me and said, "Daddy, I have a present for you!" This is what she gave me. Craft work made out of Sticky Notes with this hand written message on it --

"Things you need in life - Strength, Fitness, Focus, Happiness, Smartness, Health."

275. On Friday, September 8, 2017, as on every week, I dropped my children to school, not realizing that this was our last day of normal parenting time together.
276. A year later in supervised parenting time, on 8 Sep 2018, with my children at Color Me Mine in Ridgewood, New Jersey. My son then a helpless 12 years old, under duress, under coaching and pressure from Tracy Julian drew a sketch of his father depicting a dagger piercing one ear, exiting the other ear, blood squirting from ears and mouth.

277. If we study all forms of violence, murderers, serial predators, gun violence - very often we see in childhood the person showing extreme cruelty to animals, and drawing sketches that are clear warning signs.

278. <u>But this is the first</u> - a child, drawing a sketch of his own father - dagger through head, blood squirting.

279. Judge Terry Bottinelli, Judge David Katz and Judge Donald Kessler encouraged such heinous acts.

280. For this great accomplishment of Tracy Julian, - Judge Katz and Judge Bottinelli took away my custody and awarded Tracy Julian \$2 million in legal fees that I should pay her and then entered that as Child Support Backlog.

## PRAYER FOR RELIEF

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how did Tracy Julian accomplished this inhumane act.

2. Or in the alternative, the court will give an opinion about - what Tracy Julian accomplished was humane and should be encouraged in all family courts.

3. Only if the court encourages such inhumane, barbaric practice in all family courts all across America, only then I ask this court to dismiss this count with prejudice.

4. If the District Court is not the right venue, than I ask the court to rule, in which court should I file this appeal.

# **COUNT - 11**

# **DENIAL OF DUE PROCESS RIGHTS**

281. Every person who commits a crime, wants his victim to be silenced.

282. In engineering, we reverse engineer, we forward engineer.

283. In science we ask ourselves "what happens when? What happens when x is equal to 5, what happens when ...."

284. To have the ability to appeal, I need money to pay my legal bills.

285. To appeal, I need pay for transcripts. Tracy Julian influenced Judge Terry Bottinelli to pass such a Judgement / Order that my 40 years of blood, tears, sweat and toil have been wiped out and I have another 2 million in debt to pay, which in a premeditated manner is entered in State account books as "Child Support Backlog". And I have to pay \$7260 per month in child support.

286. Such an order was entered when my past 5-year W2 earnings yearly average was less than \$35,000.

287. On the street a thief shows a gun, a knife and steals few dollars.

288. In a family court lawyers like Tracy Julian can make a Judge pass orders, bend light, and steal millions of dollars. Judge Bottinelli passed orders - knowing fully well that all of this, one hundred percent, is going into the pocket of attorney Tracy Julian.
289. In the final Judgement of Divorce (JOD) dated February 25, 2022 Judge Terry Bottinelli ordered the following.

290. What happens when the judge orders that - the \$2 million awarded in legal fees to attorney Tracy Julian to be accounted as Child Support Backlog in state account books. This puts a parent like me into a "choke hold" which I cannot ever break free from. This is a knee to my neck. And this is happening to over 10 million parents all over America.

291. My residence 2L is a premarital asset. The Judge awarded Alina 65% and hence it becomes legal to order its sale. And this in turn makes it possible for Tracy

Julian to collect. After sale the money - my 35% goes into state treasury, from there it goes to Alina Myronova and from there is goes to Tracy Julian. At multiple levels this is serious Money Laundering.

292. Same with my two office units which are post marital assets, the judge ordered them sold and Alina be given 40%. The money follows the same money laundering route.

293. What happens when the Judge takes away every penny I have and puts me in debt of \$2 million which is illegally accounted as child support backlog. Effectively I will be unable to get money for transcripts, and hence I will be unable to file an appeal and <u>hence I will be effectively denied due process - every criminal wants his victim to be silenced</u>.

294. Add to above the Judge ordered illegally that I pay Alina \$130,888 - from rise in SpaceAge business value. At multiple levels, from multiple perspectives this award is illegal. And placing a ONE month time limit ensures that any cash I have will go to pay this and not for transcripts.

295. Add to above the judge ordered I pay \$35,000 for gag order violations and on this too there is a time limit of one month.

296. In Feb 2011, I had 6 rental properties - marital assets.

297. From 2018 to 2021 - 4 were sold. From first three, Alina was given over 70%.

298. From 4th which was sold in Jan 2021 - the money after sale was held in Alina's

attorney account and the Judge illegally converted it to UTMA - a total of \$224,985.
299. Which 12 year old child will want that she not be allowed to see her father, her father be homeless and have this \$224,985 sit in UTMA account for her college?
300. I petitioned the court to be allowed to use this for transcript fees and I will replenish it in time. The court denied it.

301. As of Feb 25, 2022, there were two remaining marital assets 12P and 5G - from their sale also the court has awarded 65% to Alina.

302. Alina contributed \$0.00 to any marital asset. Alina contributed \$0.00 to any household expense. Alina paid zero bills. Alina stole over \$300,000 from marital assets. Alina was working in my business and was paid 4 times over. Alina virtually never cooked for me or did anything that a typical spouse would do - that would entitle her to a share in rise in business value or a 65% share in marital assets. I spent much more time than Alina - taking care of my children. Alina's mother too virtually lived for free - all her expenses paid by me.

303. If we see the money awarded to Alina by the Judge, we will conclude that as per the Judge, marriage is a parasitic relationship where the wife is the parasite. But if we look closely and follow the money - then we see (a) millions of dollars moving from federal funds into State treasury and (b) millions of dollars moving into the pocket of Tracy Julian.

#### 304. What motive will any Judge have to cover up the crimes of Alina and

#### <u>Viktoriya</u>?

305. How can any judge award Alina such illegal amounts as listed above - and, all the money awarded to Alina will go to her Attorney as well. So one of the intent of awarding Alina an illegal share is so that her attorney Tracy Julian can collect over \$3 million in her legal bills.

306. What motive will any Judge have to help Tracy Julian earn over \$3 million and go out of his way to engineer the JOD to the minutest detail to ensure money flows into Tracy Julian's pocket.

307. Is this the one and only motive the Judge has - that the State should move federal funds into State treasury under Social Security Act Title IV-D?

308. The Judge awarded Alina 65% in my residence 2L which is premarital asset, and 65% in marital assets in which Alina had negative equity, and 40% in my 2 office units which are post marital assets.

309. Alina 23 years younger, with mere 6 years relationship and in college for 2 of the 6 years - awarded 65% in "equitable distribution"!

310. Even after an illegal share awarded, in a somewhat humane and honest court, the judge could have permitted shuffling, moving the percentage awarded or allowed it to be applied to another unit.

311. Alina and her mother Viktoriya have committed serious crimes - marriage fraud, immigration fraud, whiting out checks, whiting out bank statements, producing

fraudulent documents in court, perjury at an unimaginable psychopathic level, etc.

312. In family courts when a person like me has deep pockets, then a person like Alina with rich criminal history is the ideal dream client for attorneys like Tracy Julian.

313. In the interest of justice why will any State refuse to pay for trial transcript costs? What are we paying tax for?

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:1. At the very least pay for trial transcript costs. What does the State have to fear?

#### **COUNT - 12**

### KIDNAPPING AND PSYCHOLOGICAL MURDER OF CHILDREN

314. All over American in Family Courts, everyday at least a 100 children are kidnapped and psychologically murdered as I have described in this complaint.

315. During trial I had eight witnesses from the community and coworkers - who knew me and my children well.

316. During trial I had four of my family members testify.

317. During trial I had one psychiatrist, two psychologists, one therapist and the guardian-ad-litem - testify.

318. The Judge ignored the testimony of all the above.

319. If in family court we had Jury trial the outcome would have been totally different.

320. In family courts when children are kidnapped away on false charges - only and only then - the victim parent is given zero contact with the children, else the truth will be out.

321. If the Judge had awarded me any parenting time or custody, then the financial outcome would have been very different.

322. The law firm of Pashman Stein Walder Hayden and our family courts - I am not the first parent being given zero parenting time with my children.

323. The palpable, psychopathic levels of evil, cruelty that we see in family courts is what psychopaths like Hitler, Stalin, etc., inflicted on innocent people.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:
1. Do nothing. The forces of nature in family courts brought about by Social
Security Act Title IV-D are such that there is no power on Earth that can cleanse
family courts and help protect innocent helpless children from being kidnapped and
psychologically murdered.

2. In the alternative, the court will show courage to defend children.

3. Order an investigation into how widespread is this practice of kidnapping children in all courts under its jurisdiction.

#### **COUNT - 13**

### **ILLEGAL SALE OF MY RESIDENCE AND OFFICE UNITS**

324. The court awarded Alina 65% of my Pre-marital Asset - my residence (2L, 10 Huron Avenue) and 40% of my post marital asset - my two office units (1M, 1N - 10 Huron Avenue). This is clearly illegal.

325. Over two million dollars awarded that I pay Alina's legal fees and this is accounted in State account books as Child Support Backlog - is gravely illegal, evil, cruel and barbaric.

326. The Judgement of divorce is engineered so as to sell my residence and office units.

327. By accounting over 2 million dollars in legal fees awarded to Tracy Julian - as "child support backlog", the State has ensured that I am unable to even buy my residence and office units.

328. Follow the money. What happens when my residence and office units are sold? All money that is awarded to be is collected by state towards child support backlog. This is then handed over to Alina since it is "child support". Alina then hands it over to her attorney Tracy Julian since this in reality is "legal fees".

329. The Judgement of divorce says, I have an option to buy out Alina's equity in my residence. I am effectively being denied this right.

330. My office units are up for sale as well. Even though the Judge did not write

that I have the option to buy, yet like any human being, I have the right to buy anything that is up for sale. To buy my office units, since I have been awarded 60% equity, I have to merely get a bank to give me 40% as mortgage/refinance/equity line of credit. Banks are willing to give me this money. I am being denied the ability to buy my office units - i.e. to pay Alina her 40% share awarded.

331. Same on my residence. I have 35% equity. Banks are willing to give me loan - refinance, HELOC, equity buy out.

332. We do not need any trial, any evidence. All we need to do is - open our eyes, wake up and have integrity. Alina, 23 years younger, 6 year relationship, and she is awarded 65% from my premarital asset and 40% from my post marital asset.

333. If we study the 338 page judgement of divorce and compare it with the evidence, exhibits and transcripts from the "100 days trial" - we will see, how easily any lawyer like Tracy Julian can influence a Judge in family court to abuse power and accomplish thousand times more \$\$\$\$ than what a person on the street accomplishes brandishing a knife.

334. The 338 page judgement of divorce is a mind blowing evidence of the mafia lawyers like Tracy Julian, taking over the court. Has the mafia taken over the State as well? Sadly, since Feb 2011, I have seen with my eyes, what ever the family court does, no court in the land, no law enforcement branch in the land - no attorney general, can intervene. If an attorney general dares intervene, he will be forced to such cases, will be assigned such cases.

### PRAYER FOR RELIEF

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how did Tracy Julian accomplished this inhumane act

- forcing a United States Family Court judge to pass such an illegal judgement.

2. To stop the sale of my office and residence units pending trial in this court.

3. If the sale has happened then to reverse the sale.

# **COUNT - 14**

# **DENYING ME MY RIGHT**

# TO PURCHASE MY RESIDENCE AND OFFICE UNITS

335. The sale of my residence and office units as ordered by the court is illegal.

336. To take this to the next level, Tracy Julian attorney for Alina Myronova is not allowing me to buy my residence and office units.

337. All money from sale of all units-one hundred percent will go into the pocket of Tracy Julian attorney for Alina Myronova.

338. The money will flow through an illegal money laundering path. After sale,

Alina's share will go to Alina and from there to Tracy Julian. After sale, my share will

go to Child Support, from there it will go to Alina and from there to Tracy Julian.

339. Anything that is for sale in the market, I can buy.

340. Judge Bottinelli illegally awarded Alina 40% in my post marital assets 1M and 1N which house my office. If we follow the illegal judgement and if I were to purchase my office units, my purchase price will be 40% of the sale price.
341. If this happens Tracy Julian loses the 60% share on both properties which is

about \$400,000.00.

342. Tracy Julian's legal argument is that - the \$2 million plus legal fees that is awarded that I pay to her, is accounted in State books as "child support backlog" hence if I were to buy the units I need to pay not merely 40% but 100% of the sale price.

343. My legal argument is that - Judge Bottinelli laid out a payment schedule for the backlog of child support - \$1000 per week. I am current, In fact I have been paying this one week ahead of time. As per federal rules, if I am current on child support payments then if I buy or sell my car or computer or house, the State government cannot seize money from the sale.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:1. To stop the sale of my office and residence units pending trial in this court.

2. In the alternative, allow me to buy my residence and office units at a price as defined in the judgement of divorce - that I pay Alina her 65% in my residence - premarital asset and pay Alina 40% in my post marital assets - my office units.

3. If the sale has happened then to reverse the sale.

4. To follow the money, to track down the individual who pockets the money awarded to me and <u>ask that specific individual to return the money back to me</u>.
5. To identify the person(s) responsible for the sale and to hold that person fully accountable including for trauma and damages caused to me.

### **COUNT - 15**

### **BOOK: WISDOM OF THE AGES**

344. In July 2022, I published the book - Wisdom of the Ages. This book is based on my experience studying and guiding the mental, moral, psychological and intellectual development of children and young adults since 1977 -- with a focus on challenges Earth and Human Species is faced with.

345. Using my money whatever little I have left, I have been distributing copies of this book to middle schools and high schools. I asked the court for permission to mail a copy of my book to the school where my son and daughter is studying. The court denied my request.

346. As per the court, in one of the most civilized nations on earth, I do not have the freedom to mail a single copy of my book to the school where my son or daughter is

studying.

347. As per the court, in one of the most civilized nations on earth, I do not have the freedom to mail a single copy of my book to any student or teacher or to the library in the school where my son or daughter is studying.

348. As per the court, in one of the most civilized nations on earth, my book is banned in all private high schools in the State of New Jersey.

### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

 Order an investigation into how did Tracy Julian accomplished this inhumane act
 forcing a United States Family Court judge to pass such an illegal judgement that amounts to flushing our constitution down the toilet.

#### **COUNT - 16**

### **GIVING LECTURES, PART TIME WORK**

349. As the court can see from the book I published, I have given lectures in several schools.

350. I am planning to begin this work. Hence I asked the court for permissions to give lectures in schools where my son and daughter are studying. The court denied my request.

351. I am a gifted software engineer and software architect with over 30 years experience. I have taught, trained and supervised, guided several Professors and

PhDs, including two having a PhD (post doctoral) from Harvard.

352. I have even taught my children programming. As of September 2017 as a 11 year old, my son was writing programs in Java programming language.

353. I want to apply for a part time job at the school where my son and daughter are studying - to teach computer programming. I requested the court for permission. The court denied my request.

### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how did Tracy Julian is able to force Judges to pass such sweeping Gag Orders which will put to shame any Civilized Nation.

2. To express its opinion on such gag order.

3. To declare the gag order null and void.

### **COUNT - 17**

### FALSIFICATION OF RECORDS, PERJURY

354. During trial evidence was produced - Alina falsified her and her mother's bank records. Alina even admitted to this. The judge covered it up.

355. During trial Alina produce records with my forged signatures - Trial Exhibit

P630. Again Judge Bottinelli under the influence of Tracy Julian, covered it up.

356. During trial Tracy Julian called in Jacqueline Lanni from Riverside Medical

Group North Bergen to testify. She lied her guts off about my behavior during a visit

to her office for my daughter's medical records. During trial I played an audio recording of the same event which showed - Jacqueline Lanni was lying her guts off. The Judge covered it all up.

357. In December 2016 Judge Vito Sciancalepore in his 38 page judgement in DV case filed by Alina ruled that Alina is an incredible LIAR.

358. During trial through ignoring the findings and rulings of Judge Vito Sciancalepore, the FM judge essentially said that Judge Vito Sciancalepore was dead wrong.

359. Maureen Grippo worked at the Bergen County Court House in supervised visitation. Tracy Julian and her predecessor Robert Kornitzer and Judge David Katz allowed only Maureen Grippo to be the parenting supervisor - "out of court". During a motion hearing in court of Judge Katz, Maureen Grippo lied. Again I had the audio to prove this. Judge Katz refused to listen to the audio.

360. Pathological level of Perjury by Alina and Viktoriya are all over - in their entire testimony.

361. <u>Pathological level of Perjury, lying, cheating, manipulation by Tracy Julian and</u> <u>willfully producing false documents and willfully having witnesses give false</u> <u>testimony</u> - is simply shell shocking. An honest Judge would suspend her license and hold her criminally liable.

### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how did Tracy Julian can bring in false fraudulent documents and testimony and is able to force Judges to look the other way. What are the various forces of nature operating here.

### **COUNT - 18**

### I AM A SLAVE AND I AM RUNNING FOR OFFICE

362. In some sense, I am a Slave. I am running for office of the Governor. I will be eligible to run in 2027. I am eligible to run for Senator, Congress and State Senate now.

363. I want to reach out to employees of private high schools in New Jersey asking for their vote.

364. As per gag order by Judge David B Katz and Judge Terry Bottinelli, I cannot reach out to any employee of any private high school in New Jersey

### PRAYER FOR RELIEF

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how did Tracy Julian is able to force Judges to pass such sweeping Gag Orders which will put to shame any Civilized Nation.

2. To express its opinion on such gag order.

3. To declare the gag order null and void.

#### **COLLUSION BETWEEN TRACY JULIAN AND JUDGES**

365. Tracy Julian does not have to rob a Bank. Tracy Julian does not have to break into my house with a gun and rob all my money. Tracy Julian can accomplish this and much more simply by ordering a Judge to order that all my assets be sold and given to her as her "legal fees". AND why will any Judge comply so willingly? What did Tracy Julian do to the Judge that two Judges complied with all her demands one hundred percent.

366. How could Alina Myronova's attorney of 4 years, - Tracy Julian pull this off?367. How can Tracy Julian earn way over \$ 3 million in legal fees in less than four years? Do we need any investigation to conclude that this can only be accomplished through brutally evil, inhuman and corrupt ways.

368. How can Tracy Julian have two Judges pass such orders as were passed from 2017 to 2022?

369. Alina in May 2003, was 19 years old, still in college. I am about 23 years older to her. In 2004 I helped her and her mother come to America. I gave them a job in my business. Paid them salaries 3 to 4 times over. Six year relationship!

370. As per laws, after divorce, both get "50-50 of marital assets" only and only if both contributed equally. The first indicator of "both contributing equally" is their earning potential, their salary, experience and education. My earning potential and salary is at least 10 times that of Alina.

371. And then Alina stole over \$300,000 from Marital Assets and unjustly enriched herself with another \$300,000.

372. My residence can be considered both premarital and post marital, since I bought it with premarital money, then refinanced to purchase six rental units- "marital assets", and then paid off the mortgage on 2L in full after filing of divorce with post marital earnings.

373. As of 2017 - 7th year into litigation, I had 6 rental units, 2 office units and my residence - total value of about \$2 million. By the time trial ended - Dec 2021, I had 2 rental units, 2 office units and my residence, i.e. 4 rental units were already sold and over 80% went to Tracy Julian.

374. After trial, after all my assets are sold - even after that I will have about \$2 million in child support backlog!

375. The Judge ignored all money Alina stole and unjustly enriched herself with.376. The judge ordered - awarded Alina 65% in premarital asset, 65% in marital assets and 40% in post marital assets.

377. And then Tracy Julian had the judge pass the order that Alina will have Power of Attorney to sell all my assets. A 20 year old still in college, lives with a person 23 years older for mere 6 years and is given POA to sell his assets and earnings of 42 years! Imagine President Trump, his past marriages and his ex-spouses at time of divorce given 65% in all his assets and the POA to sell all his assets

378. Tracy Julian influenced the judge to award her \$2 million in legal fees that I need to pay her.

379. Tracy Julian influenced the judge to award spousal support to Alina. If we follow the law Alina should get \$0.00 in spousal support. Marriage certificate does not make Alina a parasite.

380. All spousal support given to Alina - went to her attorneys. Over 80% of child support given from 2011 to 2021, went to Alina's attorneys.

381. Tracy Julian influenced the judge to dismiss the case my business SpaceAge filed against Alina and her mother Viktoriya.

382. Tracy Julian influenced Dr. Paul Dasher to lie, she influenced Jackie Lanni to lie. Tracy Julian produced false reports from DCPP. How?

383. Tracy Julian influenced the judge to cover this up -- Alina stole over \$300,000 from Marital Assets and unjustly enriched herself with another \$300,000.

384. Tracy Julian influenced the judge to ignore, cover-up, dismiss all counts against Viktoriya - so that all money stolen and unjustly enriched - from/by Viktoriya was now available to be given to her attorney as legal fees.

385. To ensure collection, Tracy Julian influenced the judge to order that the \$2 million in legal fees that I need to pay her, be accounted in State account books as "child support" backlog. This is serious financial CRIME!

386. Every aspect of the judgement related to money is engineered with the goal

that Tracy Julian will collect her \$2 million from me and the remaining over \$1 million from the marital assets awarded to Alina.

387. Tracy Julian influenced the judge to give me zero custody and zero parenting time.

388. How can Tracy Julian have a Judge pass such orders? Do we need any investigation, evidence, trial, discovery - to conclude the - kind of influence Tracy Julian exercised on Judge Terry Bottinelli and Judge David B Katz.

389. Is this the first time Tracy Julian has accomplished such brutally, evil barbaric results.

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how did Tracy Julian is able to influence Judges to pass such brutally, evil barbaric orders causing enslavement of innocent parents.

2. To express its opinion on such gag order.

3. To declare the gag order null and void.

#### **COUNT - 20**

#### FREE MY CHILDREN

390. On 11 September 2017, I watched with horror as my children were kidnapped right in front of my eyes, in a court room, through abuse of judicial power by Alina's attorney Robert Kornitzer - the predecessor of Tracy Julian.

391. Over the next three years I watched the brutal psychological murder of my children - happening in front of my eyes.

392. This happening in one of the most civilized nations on earth in the entire history of human race and as a father I watched helplessly - unable to help my two innocent children.

### PRAYER FOR RELIEF

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Do nothing. The forces of nature in family courts brought about by Social Security Act Title IV-D are such that there is no power on Earth that can cleanse family courts and help protect innocent helpless children from being kidnapped and psychologically murdered.

2. In the alternative, the court will show courage to defend children and free my children.

3. Order an investigation into how widespread is this practice of kidnapping children in all courts under its jurisdiction.

### **COUNT - 21**

## FAMILY COURTS ORDERS ARE VIRTUAL DEATH SENTENCE

393. Is this our HUMANITY! O' GOD! What has become of us!

394. Entering Family court has now become the same as entering the Gates of HELL.

395. From Feb 24, 2011 till date, my experience and that of dozens I have spoken with personally and hundreds I have seen on social media - all over the U.S.

396. Some one plans the crime and someone executes it.

397. All over America, from the outside (of government), Attorneys like Tracy Julian, law firms like Pashman Stein Walder Hayden, Psychologists like Dr. Paul Dasher, Therapists like Kristen Luzzi-Odorisio, etc., are driving the crime. Inside the government - Judges are the one who pull the trigger. CPS-DCPP and everyone all the way up till the attorney general - directly aid-and-abet; and all elected officials at best I can say - they look the other way.

398. Follow the money - millions of dollars are sucked out of the pockets of both litigants and then the entire blame is placed on the litigant - "bitter divorce,.., bitter custody battle."

399. (a) My 42 years of blood, tears, sweat and toil - wiped away, (b) out of nowhere, over 2 million dollars in child support backlog. (c) pay \$7260 per month in child support backlog and child support. (d) given zero custody of his 2 children. (e) given zero parenting time with his 2 children - not allowed even a recent photo.
400. This order in the face of, in the light of -- (a) Malhan - 62 years old, having several health problem, he can barely work from home. (b) Malhan's business - SpaceAge - down from 14 revenue earning employees (computer programmers) in 2011 to mere 2 revenue earning employees at the time of trial in 2020-2021. Every

indication that SpaceAge can close down any moment.

401. Isn't such a sentence a virtual death sentence for at least over 90% of victim father's/mothers. How many victims will survive such a sentence? And those who survive this "death sentence", life will be a living hell!

402. Thank God I graduated from top military academy and served in the army for 11 years, and thank god I did my homework in life very diligently - building myself - intellectually, morally and psychologically.

403. Thank God, that for past 30 years I had wisely stayed "hands-on" in computer programming, hence I was able to ask a client if I can provide them computer programming services.

404. Thank God, the client allowed me to work from home considering my health challenges.

405. Thank God, I reengineered my business, from the, no longer workable "trainto-hire" model to "straight-hire" model - i.e. hiring H1B visa workers. In 2022 SpaceAge has hired 3 H1B workers and revenue from them will begin coming in - in next 5 to 15 months. And there is no guarantee!

406. At the end of the day, I can only rely on myself - on myself alone that my work servicing a client will generate enough revenue so that I can pay the whopping\$7260.00 per month in child support plus illegal child support backlog. This\$7260.00, if we ask Alina for her bank statements, we will see amounts more than

this flowing into Tracy Julian's pocket.

### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

 Order an investigation into how lawyers like Tracy Julian, law firms like Pashman
 Stein Walder Hayden, Psychologists like Dr. Paul Dasher, Therapists like Kristen
 Luzzi-Odorisio, etc., -- are able to influence Judges to inflict such unbearable trauma
 on innocent, helpless, powerless children and parents.

2. To investigate and express its opinion if people in family courts are indeed experiencing trauma to a level as if living in HELL on Earth and if anyone inside and outside the government is responsible for this.

3. To offer its opinion why a sentence such as in my case is not a virtual death sentence.

### **COUNT - 22**

## BANK ROBBERY: BANK OF SURENDER MALHAN

407. This is a mind blowing case where we all can see - in family courts how easily attorney's like Tracy Julian can rob Bank of Surender Malhan, get away with over \$2 million and then enslave Surender Malhan to work and pay another \$2 million, illegally entered as backlog of child support. Such a bold, daring, audacious, broad daylight bank robbery without using any guns, and virtually the entire state supporting this, and the attorney general fighting hard to have this case dismissed!

408. On paper "35% to Surender, ... 65% to Alina", on ground - 100% into Tracy Julian's pocket. On paper "\$2 million child support backlog", on ground, all of this we see going into Tracy Julian's pocket!

409. Based on numerous family court cases I have seen since Feb 24, 2011, there is no other case more serious than Myronova v. Malhan.

410. This case needs - no discovery, no interrogatories, no depositions and no trial.

411. Just mere this fact is sufficient for 5-Alarm fire alarm to go on all over.

412. (a) Alina Myronova from Ukraine - 20 years old, (b) still in college for next 2 years, (c) lives with Surender Malhan, 23 years older for mere six years; (d) Malhan is earning at least 10 times more, (e) Alina is not a house-wife, (f) Malhan gives her a job in his business and pays her salary at least 3 times over. (g) After mere 6 years, Alina gets her green card and files for divorce. (h) 11 year litigation. 100 days trial. Alina is awarded 65% in pre-marital asset, 65% in marital assets (in reality over 80%) and 40% in post marital assets. (j) And for his 2 children, Malhan is given zero custody and zero parenting time.

413. Isn't this sufficient for a 5-Alarm fire alarm to go on.

414. If not then add more indisputable facts.

415. All money - awarded to Alina and Malhan - all of it 100% flows into the pocket of Tracy Julian. How can any attorney bill over \$3 million in legal fees in less than 4 years.

416. If Tracy Julian had robbed a bank of mere \$1000 how would every one respond.

417. Here Tracy Julian has robbed the Bank of Surender Malhan - got away with over \$2 million and at least 2 Judges aided and abetted. Same as sometimes bank employees aid and abet bank robbery.

418. If above is not sufficient then add more indisputable facts.

419. \$2 million in legal fees that Malhan is ordered to pay Tracy Julian is accounted in State books as "Child Support Backlog". How can any individual or business get away with this kind of financial crime.

420. And then to take it to the next level, Tracy Julian gets the Power of Attorney to sell all my assets - Pre marital, marital and post marital.

421. How on earth can anyone wrap their hands around this - that Alina Myronova is given the POA to sell all my assets.

422. All money 100% is going into the pocket of Tracy Julian and that helps understand why Alina is given POA.

423. Could the above result from "<u>following the law</u>."

#### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how lawyers like Tracy Julian, coerce the judges into robbing the Bank of every litigant in court.

#### **COUNT - 23**

In family court kidnapped is called change in custody / parenting time - done in the "best interests" of the children, done to "protect the children". After his millions of dollars in ransom money - called legal fees, extracted through mere court orders.
425. Over next 2 years Tracy Julian with the help of two judges, psychologists, therapists - caused the psychological murder of my children as written below.
426. Tracy Julian forced my children to disown their father. They were forced to tell

their father "you are not my daddy!"

427. When I was standing mere 2 feet in front of my children, Tracy Julian forced my children -- not to look at their father, even when he was standing in front of them, 2 feet from them for one full hour.

428. Tracy Julian forced my children - not to touch their father, not to hug their father, not to call their father "daddy".

429. The above is an extremely incomprehensible, extremely bizarre phenomenon.

430. If we follow the money, as a result of above, Tracy Julian earned over \$3

million in legal fees in less than 4 years.

431. During the 100 days trial not a shred of evidence was produced that will scientifically back up the above behaviors forced upon the children, i.e. there was nothing that even remotely suggested that any behavior of the father cause the children to disown him, not look at him.

432. We don't need any trial to prove above. The mere inconsistency in children's behavior is enough. A drop of humanity in the heart of a Judge or jury is enough.433. The above phenomenon is super stunning for the average Joe and Mary.

### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how lawyers like Tracy Julian, coerce the judges into inflicting such incomprehensible trauma on children and parents.

2. Or in the alternative rule that such behaviors in family courts in the United States of America - is common and acceptable.

### **COUNT - 24**

#### SALE OF UNITS 2L, 1M, 1N

434. 2L is my premarital unit. 1M, 1N are my post marital units. 12P and 5G are the remaining 2 out of 6 marital units as of the Judgement of Divorce on Feb 25, 2022.

435. Alina was awarded 65% in 2L, 12P and 5G.

436. Judge ordered all listed for sale. It was expected that considering my financial

situation and the way the judgement of divorce was engineered, -- all sale will go through and all money, - my share and Alina's share will 100% go into the pocket of Tracy Julian.

437. Judge gave me option to buy on 2L, 12P and 5G. My understanding is - this is because I am minority share holder.

438. Judge did not give me option to buy on my office units 1M, 1N. My understanding is - this is because I am majority share holder - 60%.

439. Even if I don't have option to buy, <u>I have the right to buy anything on sale in</u> the market.

440. Also, as per law, as a majority share holder, I have certain rights over the property, which the Judge did not rule as null and void.

441. Judge gave Alina "limited POA", to sell the units. That does not mean that she will cause me and my business "irreparable harm".

442. If we follow the money, if I buy out all 3 units then Tracy Julian will pocket at least \$400,000 less.

443. I am close to obtaining a Home Equity Line of Credit on my residence 2L. As of October 22, 2022, the processing is paused at -- the appraiser noted that the property is listed for sale and there is a current buyer - and it is under contract.
444. On September 27, 2022 in court of Judge Peter Melchionne, the Judge said,

words to effect that "Malhan has the option to buy, this is not written in the current

contract, hence current contract is not legal. Malhan can exercise his option to buy."

445. After I obtain the HELOC, I have the next Bank lined up for another loan to pay Alina her 40% on my office units 1M and 1N.

446. Tracy Julian is gripped with anxiety and is racing to sell 1M, 1N ASAP. Tracy Julian is sell them at throw away prices - reducing from listing price by well over \$100,000.

447. In past few months, I have several times written to Alina and her realtor Muriel Paton and her real estate attorney Dennis Collins that I am buying all units 2L, 1M and 1N. I will pay at listing price or higher than the listing price. I will match any

offer Alina gets. I will pay \$1000 more than any offer that Alina gets.

448. Every one is well aware that myself and my business SpaceAge will be

irreparably harmed if I am not allowed to buy my residence and I am not allowed to

buy my office units.

449. Add to above, I have pending Appeal filed in Appeals Court.

450. I have emailed Alina, realtor Muriel Paton and Attorney Dennis Collins the following:

Please know and please inform all buyers for units 1M and 1N that: (a) I have 60% equity.

- (b) This is post marital assets.
- (c) I have an appeal filed, and in 2 weeks or less a federal case filed.
- (d) I have made repeated offers to buy the units.

(e) I will match any price you get - or if required pay \$1000 more, or if required pay \$5000 more.

(f) I have obtained funds to buy.

(g) The Judgement of divorce - nowhere does it say "Surender Malhan cannot buy units 1M, 1N".

(i) As any adult citizen, I can buy anything that is on sale.

(j) SpaceAge has a 5-year lease. 1M, 1N are commercial properties.

..... (in another email)

Now lets analyze why the Judge explicitly wrote that I have option to buy for 2L, 12P and 5G. This is because you are given majority share -65% and the judge wanted to guarantee me my rights - that I have the option to buy.

For Units 1M, 1N which are post marital and again you should be given 0%, yet the judge gave you 40%. Here the judge did not feel the need to explicitly write that Surender Malhan has the "option to buy" because, Surender Malhan has "60% share in the property" -- MAJORITY SHARE!

Having a majority share in any business, property or any asset means that I have certain legal rights, I have voting rights, I have the right to veto your decisions on who will buy - especially when the person who buys (such as myself), is paying more than the buyer you have.

2. Allow me to purchase my residence and office units i.e. pay Alina her share

6. To identify the person(s) responsible for the sale and to hold that person fully accountable including for trauma and damages caused to me.

452. Evil, Crime, Corruption - is pervasive. So pervasive that this case or any case like this will not see the light of the day.

453. So pervasive that a victim of crime cannot find justice anywhere - State
Appeals Court, State Supreme Court; Ethics committee for Judges, Psychologists,
Lawyers; Federal Court, Attorney General, Governor, Elected Representative, etc.
454. Is there one place, one office - where the virus of Evil, Crime, Corruption has
not spread into.

455. Attorney Paul Clark served in the Marines. His father, a veteran who lost alimb (passed away recently). Paul Clark has represented me very bravely since 2013.

He has risked it all.

456. Evil, Crime, Corruption is so widespread and powerful that if they find an honest attorney like Paul Clark they are out to destroy him.

457. Retaliation against the attorney who represented me, has impacted me and many more victims.

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Order an investigation into how lawyers like Tracy Julian can leverage the State machinery to retaliate against an honest attorney.

2. Order an investigation and identify all departments and parties involved.

#### **IF DISMISSED THEN**

458. If this case is dismissed, one count, any or all; then for counts dismissed, in the interest of justice I asked the court and attorney general to suggest the proper venue for filing of this case.

WHEREFORE, Plaintiff expects that a honest, humane, law abiding Court will:

1. Suggest a proper venue or in the alternative ask the attorney general to suggest the proper venue for filing of this case.

### CONCLUSION

459. This is happening all over America. Poor helpless children are kidnapped away from one or both parents and in cold blood, brutally - psychologically murdered.There are children who commit suicide as a result, there are parents who commit suicide.

460. This is happening all over America. The central goal in every case is to rob the Bank of Litigants Joe and Mary. The central goal in every case is (a) extract all assets. (b) make both earn for decades and extract all earnings. This is SLAVERY version 2.0!

461. Stepping into a Family Court is like stepping into Hell on Earth. I have spoken with several people who wished they were not alive - the pain and suffering is so unbearable and "unending".

462. The number one goal in family court is - (a) to extract all assets of both litigants. Often it is "all" for one litigant and the other is left with some if lucky. (b) to make both litigants work multiyear and extract their earnings as well.

463. Stepping into a Family Court, is in itself - "enslavement". Judge and all players there - attorney, psychologists, etc., are the Masters. And the Master is Evil, Cruel to the bone. No mercy, no kindness - even to poor, helpless children. If anyone on this team shows kindness, he is removed.

464. <u>In the final analysis the results produced show intellect, integrity and character.</u>I have seen with my eyes the words, actions, body language, walking-talking style

470. I have spent enormous amount of time in filing this petition. I don't have time and money. The State has resources, time and money. They have nothing to lose.

471. Power, Secrecy, Greed and Lack of Accountability - will turn even God into a

472. A hundred years from today none of us will be on Earth. Why are we making life a living hell for another human being? For what?
